Dear Mayor and City Council,

I am a former public school teacher and current volunteer reading tutor at Madison Elementary School. I'm writing to express my support of the use of closed PUSD school sites for affordable staff and family housing.

I'm a staunch defender of the public school system, so it's sad to know that 11 PUSD schools have closed in the past couple decades. Even though this is due to many factors such as rising housing prices and demographic shifts, it looks and feels like yet another painful strike against a school district that has such wonderful things to offer. It's even more painful to see these campuses rented out to charter schools which are in direct competition for student enrollment.

This is why I am thrilled that the PUSD board has decided to move forward on proposals to build affordable housing for PUSD staff on one of these closed school sites. Not only would PUSD staff have the option to live in the communities which they serve, but this type of land use would provide a desperately needed income stream for the district. This would be immeasurably more beneficial for the than losing more money trying to maintain aging buildings that are not going to be repopulated by students any time soon. I'm also encouraged that the PUSD board is investigating using a second closed school site for housing for PUSD families.

There are many more rational reasons why affordable staff and familiy housing is a good idea, but there are emotional ones as well. If I had friends or family visiting Pasadena for the first time I would not want to drive past a closed PUSD school that was being used by a charter school. But I would proudly show my visitors a site that had been converted into affordable housing for PUSD staff and families. I would be able to say to my visitors: "PUSD is a district that is committed to its staff, teachers, and students, and its leaders are taking concrete steps to build a stronger community by providing a way for them to live in city they serve."

Please make this a reality by supporting PUSD in whatever ways the City Council can to make these initiatives a reality.
