#### **CEREMONIAL MATTERS**

Mayor Gordo introduced the 2024 Rose Court Chair/Director Missy Baiunco Augustyn. Ms. Augustyn introduced the 2024 Rose Cour Queen Naoimi Stillitano and Princesses Olivia Bohanec, Trinity Dela Cruz, Phoebe Ho, Mia Moore-Wallker, Jessica Powell, and Emmersor Tucker. Mayor Gordo presented certificates of recognition to the 2024 Rose Court for their dedicated service in representing the City.

Koko Panossian, Parks, Recreation & Community Services Director provided introductory remarks about upcoming events to celebrate Black History Month, and introduced Jennifer Colby, Public Informatior Coordinator, who shared information and event details on the upcoming Black History Parade on Saturday, February 17, 2024, and the Mard Gras themed Senior Night Out on Friday, February 23, 2024.

Mayor Gordo invited the community, City staff, and City Council to the upcoming Mayor's State of the City on Thursday, February 29, 2024.

Mayor Gordo requested that the meeting be adjourned in memory of Marty Coleman, a long-time Pasadena resident who previously served as the Outreach Director for the Inter-Faith Center at All Saints Church and reflected on her social activism within the community.

- (2) Authorize the City Manager to amend Contract No. 32329 with Raftelis Financial Consultants Inc., dba Raftelis ("Raftelis") for Water Cost of Service Analysis ("COSA") and rate design services from a not-to-exceed amount of \$157,724 to \$211,708 and extend the expiration to December 31, 2024. The total \$53,984 amendment includes the base amendment of \$46,943 and a 15% contingency of \$7,041, to provide for any necessary change orders. (Contract No. 32329-2)

### REJECT ALL BIDS TO FURNISH AND DELIVER CONCRETE MATERIALS FOR THE WATER AND POWER DEPARTMENT (Water & Power Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed action is exempt from the California Environmental Quality Act ("CEQA") pursuant to Public Resources Code Section 21080(b)(5) (projects which a public agency rejects or disapproves) and Section 15270 of the State CEQA Guidelines; and
- (2) Reject all bids received on December 5, 2023, in response to the Notice Inviting Bids to Furnish and Deliver Concrete Materials.

# MUNICIPAL SERVICES COMMITTEE: SET PUBLIC HEARING FOR APRIL 8, 2024, FOR PROPOSED SEWER USE FEE RATE STRUCTURE AND RATE ADJUSTMENTS (Public Works Dept.)

**Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed action in the agenda report is not a project subject to the California Environmental Quality Act (CEQA) Public Resources Code Section 21065 and Section 15378(b)(4), and that the proposed sewer use fee increases are statutorily exempt pursuant to Section 15273 (Rates, Tolls, Fares, and Charges) under State CEQA Guidelines, and as such, is not subject to environmental review;
- (2) Set a public hearing for April 8, 2024, regarding proposed Sewer Use Fee rate structure and rate adjustments; and

(3) Direct the Public Works Department to mail notices of public hearing set for April 8, 2024, regarding proposed Sewer Use Fee rate structure and rate adjustments.

Recommendation of the Municipal Services Committee: On January 23, 2024, the Municipal Services Committee (MSC) voted unanimously to forward this item to the City Council to set the public hearing date. A committee member suggested that the proposed rate should be phased-in over the next five-years to allow customers to adjust to the overall proposed increase over time.

### MUNICIPAL SERVICES COMMITTEE: SET PUBLIC HEARING FOR APRIL 8, 2024, FOR PROPOSED REFUSE COLLECTION FEE INCREASES (Public Works Dept.)

**Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed action in the agenda report is not a project as defined in the California Environmental Quality Act (CEQA) Public Resources Code Section 21065 and Section 15378(b)(4) of the State CEQA Guidelines, and that the proposed refuse collection fee increases are statutorily exempt pursuant to Section 15273 (Rates, Tolls, Fares, and Charges) of the State CEQA Guidelines, and as such, is not subject to environmental review;
- (2) Set a public hearing on April 8, 2024, regarding proposed refuse collection fee increases; and
- (3) Direct the Public Works Department to mail notice of public hearing set for April 8, 2024, regarding proposed refuse collection fee increases.

Recommendation of the Municipal Services Committee: On January 23, 2024, the Municipal Services Committee (MSC) voted unanimously to forward this item to the City Council to set the public hearing date. A committee member suggested that the proposed rate increase for the residential 32, 60, and 100 gallon containers should be equal. The proposed monthly rate increases are \$8.47, \$8.75, and \$5.62 respectively.

CONTRACT AWARD TO A&Y ASPHALT CONTRACTORS INC., TO FURNISH LABOR AND MATERIALS FOR UTILITY AND MISCELLANEOUS STREET REPAIRS FOR AN AMOUNT NOT-TO-EXCEED \$1,500,000 FOR THE WATER AND POWER DEPARTMENT (Water & Power Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed action in the agenda report is not a project subject to the California Environmental Quality Act ("CEQA") pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines, and as such, no environmental document pursuant to CEQA is required for this action;
- (2) Accept the bid dated November 13, 2023, submitted by A&Y Asphalt Contractors Inc., ("A&Y") in response to Specifications WD-23-04; reject all other bids received; and
- (3) Authorize the City Manager to enter into a contract with A&Y for an amount not-to-exceed \$1,500,000 for an initial period of one year, whichever comes first, with an option for two additional one-year terms at \$1,500,000 per year, at the discretion of the City Manager, for a maximum total amount not-to-exceed \$4,500,000.(Contract No. 32845)

Greg Fleming, Paveco Construction, Inc., expressed concerns about the bid process as the current contractor, and provided comments on what his company's bid amount would have been if Paveco would have received notice of the process.

Sidney Jackson, General Manager of Pasadena Water & Power, spoke on the City's procurement process for this project, and stated that selected bidder, A&Y Asphalt Contractions, Inc., was the lowest bid received.

In response to questions, Yan Qu, Water & Power Principal Engineer, stated that staff reached out to the current contractor, Paveco Construction, Inc., when bidding opened in October 2023.

Councilmember Hampton expressed concerns with the OpenGov bidding and contracting system, noting that some companies may not use or be familiar with the system, and are at times unaware of the timing to rebid expiring contracts; and he advocated for the City Council to reject all received bids and start the bidding process over.

City Attorney Bagneris clarified that the City Council can either approve the staff recommendation, continue the item and request staff to present additional information on the bids received, or reject all bids and restart the bidding process, which may delay projects.

Mayor Gordo expressed concerns that starting the bidding process over would be unfair to those who submitted bids, noting issues of equity/fairness and potentially undermining the City's competitive bidding system.

General Manager Jackson stated that the City has ongoing watermain replacement projects pending, and delaying this procurement would create time challenges to address these important issues.

It was moved by Councilmember Hampton to continue the item, with direction to City staff to gather additional information on the details of the bidding process, based on public testimony, and report back to the City Council. Motion failed due to lack of second.

### ORAL REPORT: PASADENA POLICE DEPARTMENT "YEAR IN REVIEW 2023" PRESENTATION

**Recommendation:** This matter is presented for information only; no action is required.

Eugene Harris, Police Chief, provided a brief introduction and reviewed the item as part of PowerPoint presentation, highlighting retirements within the command structure of the Department, transition priorities, structural and cultural changes, statistics on computer aided dispatch, crime and response-time data, hiring and personnel demographics data, and the Police Department's process of contemporary rebranding.

In response to Councilmember Williams inquiry about recruitment, Police Chief Harris stated that the Department is trying to develop financial incentives to increase participation in recruitments to find higher level applicants.

In response to Councilmember Lyon's questions and concerns regarding the data indicating an overrepresentation of African Americans in traffic stops and arrests, Police Chief Harris noted that the statistics also include visitors to the City, whose population grows exponentially during the daytime and on weekends.

Councilmember Hampton suggested incentivizing employees to become residents of Pasadena, as a way to promote and foster community engagement and connection. Police Chief Harris shared that employees are encouraged to join local organizations such as Rotary, Kiwanis, etc., to engage and be part of the community they serve

In response to Councilmember Masuda's inquiry regarding employee training, Police Chief Harris stated that emotional intelligence training is critical aspect of the Department's focus, noting that many of the personnel being hired are individuals that come from a variety of backgrounds and experiences, which can influence their policing practices.

Following discussion, by order of the Mayor, and consensus of the City Council, the information was received and filed.
