Approval of Final Tract Map No. 52532, Being a 6-Unit

Condominium Project at 493 South Euclid Avenue

RECOMMENDATION:

It is recommended that the City Council adopt the attached resolution approving the final Tract Map No. 52532 and authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

BACKGROUND:

The subject tract map, a 6-unit condominium project at 493 South Euclid Avenue, was reviewed and approved in tentative form by the Subdivision Committee on August 12, 1998.

The developer's engineer has now completed the final map which has been checked by the County, monumentation has been established and checked, and said map is now ready for the city Council approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City.

HOUSING IMPACT:

The 6-unit condominium project will replace an existing two (2) unit residential dwelling, thereby resulting in an increase to the City's housing stock.
