AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 17 (THE ZONING CODE) TO PROHIBIT OFF-PREMISE SIGNS (BILLBOARDS) IN THE GENERAL COMMERCIAL (CG) AND GENERAL INDUSTRIAL (IG) DISTRICTS.

SECTION 1. The definition of "sign, off-premises" contained in Section 17.12.020 entitled, "Rules of construction and definitions" of Title 17, is amended to read as follows:

"Sign, Off-Premises. "Off-premises sign" means a sign that directs attention to a business, commodity, service, entertainment or attraction sold, offered or existing at a location other than upon the same lot where the sign is displayed. This includes, but is not limited to, billboards."

- SECTION 2. Subsection B of section 17.72.010 entitled, "Specific purposes and applicability" is amended as follows:
 - "B. Prohibit off-premises signs."
- SECTION 3. The schedule entitled, "Standards for On-Premises and Off-Premises Signs" of Section 17.72.030 is amended as shown in Exhibit 1, attached hereto and incorporated by this reference.
- SECTION 4. Subsection "H" of the "ADDITIONAL SIGN STANDARDS" of Section 17.72.030 is hereby repealed.
- SECTION 5. Section 17.72.060 entitled, "Prohibited signs" is amended by adding the following:
 - "H. Are off-premises signs."
- SECTION 6. Section 17.76.070 of said code entitled, "Effect of condemnation of a portion of a lot or site" is amended by adding the following new subsection:
- "C. Off-Premises Signs. Any off-premises sign located on property acquired for public use may be relocated on the same lot or site through the approval of a minor conditional use permit."
- SECTION 7. This ordinance shall take effect immediately upon the its publication.
