RECOMMENDATION:

It is recommended that the City Council:

- (1) Adopt a resolution approving Program Supplement No. M048 to Administering Agency – State Agreement No. 07-5064 between the City of Pasadena and the State of California for authorization to request State Reimbursement for preliminary engineering of the project: Orange Grove Boulevard - Raised Center Medians at Lake Avenue, and
- Authorize the City Manager to execute the same on behalf of the City. (2)

BACKGROUND:

The Orange Grove Boulevard – Raised Center Medians at Lake Avenue project is included in the approved Capital Improvement Program. The project consists of the construction of raised center medians in Orange Grove Boulevard from approximately 295 feet west of Lake Avenue to approximately 285 feet east of Lake Avenue. The Department of Public Works has obtained authorization from the State Department of Transportation to proceed with design. The request for Federal reimbursement of 87.5% of the design costs requires City Council approval. The City has appropriated \$28,000 which represents the difference between the total cost of the project and the amount of Federal reimbursement.

The State of California acting through the California Department of Transportation (Caltrans), administers certain federal transportation funds. These funds are paid to the City of Pasadena pursuant to the provisions of Administering Agency -State Agreement No. 07-5064 (City of Pasadena Agreement No. 16,298) entered into by the parties on April 8, 1997. To obtain funds for a specific project it is necessary to execute a separate supplemental agreement for the project after it has been approved for funding by Caltrans and the Federal Highway Administration.

Program Supplement No. M048 will provide reimbursement of up to \$21,600 in Federal Surface Transportation Program funds for the design of Raised Center Medians in Orange Grove Boulevard at Lake Avenue.

FISCAL IMPACT:

Approval of Program Supplement M048 to Administering Agency State Agreement No. 07-5064 will enable the City to obtain Federal reimbursement of eligible design costs. Funds in the amount of \$28,000 are available in Budget Account 75032 to cover the City's share of project costs.
