SUSPENDING SECTIONS 9.36.220 AND 9.36.230 OF THE PASADENA MUNICIPAL CODE RELATING TO LIMITATIONS ON HOURS OF OPERATION OF AMPLIFIED SOUND AND NOISE SOURCES FOR CALVARY CHAPEL'S EASTER SUNRISE SERVICE, A PERMITTED EVENT, AT VICTORY PARK FROM 7:00 AM TO 8:30 AM ON SUNDAY,

TITLE OF PROPOSED ORDINANCE:

AN UNCODIFIED ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTIONS 9.36.220 AND 9.36.230 OF THE PASADENA MUNICIPAL CODE RELATING TO LIMITATIONS ON HOURS OF OPERATION OF AMPLIFIED SOUND AND NOISE SOURCES FOR CALVARY CHAPEL'S EASTER SUNRISE SERVICE, A PERMITTED EVENT, AT VICTORY PARK FROM 7:00 AM TO 8:30 AM ON SUNDAY, APRIL 11, 2004.

PURPOSE OF ORDINANCE:

This proposed ordinance will suspend the Noise Ordinance for a permitted event at Victory Park during specified hours on Sunday, April 11, 2004. The enactment of this proposed ordinance is needed for the event to take place.

The City Council is considering approval of this event at the February 23, 2004 City Council meeting. If approved, first reading of this ordinance will occur.

REASON WHY LEGISLATION IS NEEDED:

The Noise Ordinance was enacted by ordinance and can only be suspended by an ordinance of the City Council.

ENVIRONMENTAL IMPACT:

The Environmental Administrator has determined that the Temporary Use Permit and the ordinance necessary to hold this non-profit event are categorically exempt from CEQA under CEQA Guidelines Section 15323, Normal Operations of Facilities for Public Gatherings. This action to allow Easter Sunrise Service is normal operation for public gatherings in Victory Park.
