SUBJECT: AUTHORIZE PURCHASE ORDER WITH WONDRIES FLEET

GROUP FOR PURCHASE OF TWELVE NEW POLICE VEHICLES

FOR A TOTAL OF \$281,775

RECOMMENDATION

It is recommended that the City Council;

- 1) Authorize the issuance of a purchase order to Wondries Fleet Group in an amount not to exceed \$281,775 for the purchase of Twelve (12) Police Vehicles.
- 2) The proposed purchase order is exempt from competitive bidding pursuant to City Charter section 1002(H), contracts with other governmental entities or their contractors for labor, material, supplies or services.

BACKGROUND

Due to the nature of its operations, the Police Department requires specialized vehicles. The Public Works Department, together with the Pasadena Police Department, have written specifications for a heavy duty vehicle. The lifecycle of police patrol vehicles is three (3) years and detective vehicles are six (6) years. The proposed purchase will replace vehicles that have met or exceeded their lifecycle. The vehicle replacement/condition reports are attached.

On December 25, 2003, the City of Pasadena undertook a competitive bidding process for the purchase of 14 Crown Victoria Police Interceptors. As a result of the bid process, a purchase order was issued to Wondries Fleet Group. Wondries Fleet Group has offered to extend this 2004 price for an additional twelve (12) Police Interceptors due for replacement in FY2005. Purchasing the requested vehicles from Wondries would be in the City's best interest because it would expedite the delivery of the vehicles and save the City

approximately \$7,822 in price increases for model year 2005, as well as any staff costs incurred in a formal bid process.

FISCAL IMPACT

This equipment is a budgeted replacement and sufficient funds are available in the Equipment Replacement Fund, account #766300.
