I am writing to encourage you to support Polytechnic School's Amended Master Plan. I was actively involved in Poly's master plan application in the early '80s and believe that the current proposal reflects the same type of commitment that Poly has to our community that was present when I was involved. I understand that the Board of Trustees and the Head of School have worked long & hard on this plan and are finally at the point where they believe they have the ideal blueprint for moving forward over the next decade, one that will fill the needs of the many constituents of the Poly community at the same time that it addresses neighbors' concerns and enhances our neighborhood.



I am writing to you as a former parent and trustee of Polytechnic School to express my support for the proposed amended Master Development Plan.



Developed in response to ongoing neighbor concerns and input, the Amended Master Plan has included a two-level underground parking facility on campus. This parking facility offers a long-term and comprehensive solution to issues of traffic and parking generated by Poly drivers. 


Dear Ms. Streeter,


We were supposed to have sent this letter earlier (and to a P.O. box) so we're hoping you'll forgive us for dropping this off at your house.

Hi Robert,

I'd like to add a few comments about the Polytechnic School master development plan and won't be able to attend. Please distribute these comments to the board, thank you.

The Public Hearing Notice reads 2004-2010. It's 2005, so this Master development plan is only going to be effective for 5 years. The plan contains elements that the surrounding residents object to, but tolerate, as well as elements that the school is attempting to appease the surrounding residents. We need this master plan duration extended 2015, or to specify what is going to be done by 2010, and to put in writing that the latter elements of the plan are to be included in the 2010-2020 master plan without more negotiation at that time. This is critical to neighborhood acceptance, since many of the latter phases are those which benefit the residents.

I'd like to see that the City amend it's master plan procedures so that a list of obligations to the community by the institution under review is created. At the end of the period, the list is reviewed, and outstanding obligations become non-negotiable portions of the next master plan to be done prior to any other improvement activity. Poly has had a problem in leaving unsolved problems from the prior master plan (sidewalks along Wilson) and it's not clear when this will be addressed, and there seems to be no sanctions or monitoring being placed on the school by the City. The current plan, being a 10 year plan in a 5 year period is weakening the sprit of the master planning process by leaving a loophole of when the school fulfills obligations to the community

I'd also like to ask for a ban on signs, posters or banners of any sort on the outside fencing of the school. I don't think this is just a Poly problem. It should apply to all schools. The problem is that many drivers slow to look around or through parked vehicles to read whatever has been put up. Their eyes are not on the road while children are being unloaded for school. Poly should consider placing posters just inside the gates, if they want to get student attention. Getting

We have met at various Geoff and Reba Thomas events. I am the Polytechnic School English teacher who performed the wedding ceremony for Derek and Tara. I write you today as a senior faculty member (twenty-five years at Poly) to ask you to vote for the approval of the school's amended Master Plan.

I assume that you are familiar with the school's claims that the underground garage is a long-term, comprehensive solution to the parking issue and that it goes nearly all the way to solving the traffic issue. I am not indifferent to the changes in the quality of life that noise and cars make. My wife and I rented a CalTrans house at 765 South Pasadena Avenue, directly across the street from the Huntington Hospital, from 1973 to 1996. We remember the day that street changed form being a quiet two lane street from some idyllic second grade reader to being a one-way virtual freeway along which would roar thousands of cars a day. We felt betrayed and powerless.

I refer to our experience only to emphasize my sensitivity to Poly's neighbors' concerns about noise and traffic. I am not aware of any feelings of betrayal and they have certainly not been powerless. I want you to know that most adults at Poly want to make our noise and traffic impact as light as possible. Many of us regularly walk the perimeter of the campus to see that our students are obeying all of the school's new rules about the use and parking of cars.

The Master Plan includes a pool and a pool can mean more than a facility for recreational swimming, training, and competition. It can't rival the ocean for "driving off the spleen" as Ishmael says in *Moby Dick*, but there is something almost spiritual about having a clear body of water at hand to simply visit if not to enter. I would love to have this opportunity. In my case the opportunity would also

I write to you as a neighbor, alum and aquatics coach of Polytechnic School with regards to the institution's Master Plan. As you can probably guess, I have a genuine interest in seeing the Master Plan process come to an end because of the first project slated for construction – the swimming pool.

Poly has a tremendous history in the aquatics sports – water polo, swimming and diving for both boys and girls. Our program has produced 8 All Americans since 1981, several CIF Champions and numerous League Championship individuals and teams. Some of our athletes have gone on to compete at Stanford (one diver was an NCAA Diving Champion!), USC, Brown, Princeton and Harvard. Our current All-American, CIF and League Champion will be headed to Princeton this coming fall.


We have accomplished all this without the benefit of a pool on our campus, having to rely on places like Caltech, Pasadena City College and Blair High School for most of our training and competition. Places where we have to get in our cars and travel during the peak traffic period after school. A facility on campus would mean we can keep the kids here and not contribute to the growing traffic problems.

Over the course of the last two years, our program has suffered because of the lack of a home facility. During this time, we have used a total of EIGHT different pools for training and competition – ranging from public facilities to rival high schools to a local country club and even backyard pools of Poly families! This clearly is not an ideal situation for the program.

The availability of pools in the Pasadena area is rapidly dwindling because of the growth of aquatics sports in the local area (3 club swim teams call Pasadena home!) which leads to more high schools starting to offer programs (Maranatha in swimming, Blair in water polo, La Salle in girls water polo are just a few programs starting up in the past year). Needless to say, there's a need for more pools in Pasadena. Approval of the Master Plan would end our need to use available pools in the area!

In closing, I know you have worked extensively with members of the Poly community and the neighborhood to resolve issues surrounding the Master Plan. I appreciate all the effort and countless hours that go along with this and I hope this letter gives you a good idea of what my aquatics program has accomplished. We are certainly looking forward to having a pool we can call our own!
