Mr. Mayor and City Council Members,

Thank you and the City Staff for your consideration and work on finding an equitable solution to the problem posed by the over-scale building that has been permitted for 1150 and 1140 North Allen Avenue—tentative tract map #062725. And thank you for putting this item on the formal agenda after hearing our request last week.

We are here because we truly believe that we have a great city and that is in part due to our great neighborhoods. In the past few years Pasadena has seen numerous new developments – many in suitable locales around town. We now have neighborhoods for every taste – from hip-urban high rise to quiet suburban residences. This variety, in the correct locations, helps make this a dynamic city – “thus achieving a livable city that balances the needs of residents and businesses,” as the website for the Zoning Staff reads.

However, when a development is out of scale with the neighborhood for which it is proposed we all lose something as a city. Developments like the one we are discussing tonight, as well as others around town which have given rise to the issue of the moratorium also being discussed tonight, destroy what has made Pasadena unique and livable.

In the August 2005 issue of Outside Magazine, Pasadena was named one of the “the new American dream towns” and was part of a list of the top ten most livable small cities in the US. The article heralded Pasadena as one of the “real American cities .. taking positive steps to soften the rough edges of our high-octane day-to-day [lives]. … shining prototypes for what a 21st-century town … can be: cleaner, greener, smarter. Better.”

As one of the reasons for choosing Pasadena, the article stated: “Since the Metro Gold Line light-rail train opened in 2003, linking the suburb with downtown L.A., Pasadena has become a hub for innovative mixed-use development...”

I am not against mixed use development that is in scale with our North Allen Avenue neighborhood. I find that to be one of the things that gives character to the neighborhood. I really enjoy the fact that we still have mostly individually owned businesses – rather than national franchises along Allen Avenue and Washington Blvd. Although the wonderful variety of Armenian bakeries has not fostered my losing any weight!

But the serious issue here is not whether this development is mixed commercial and residential, but the fact that it is out of scale with the neighborhood. This development would face on both Brigden Road – a residential single family block – as well as the commercial area of Allen Avenue. The three story height would be on both streets. This is totally incompatible with the fabric of our neighborhood.

It is intuitively obvious that this development will be out of scale with the rest of the neighborhood and surrounding area. There are no other three story structures on Allen Avenue north of the 210 Freeway (with the exception of a portion of Marshal Fundamental School and a portion of Mt. Olive Church).

Many of the concerns voiced by my neighbors – traffic, density, overflow parking – would be lessened if this building were only two story and thus had less tenants. I do hope that the city council and staff can work with the developer to achieve this goal.

Two years ago I requested that the City Parks Department put this property on the list for consideration as a pocket park. Now that dream is overshadowed by my worse nightmare of this development becoming the first in a line of dominos of densification along Allen Avenue. Please don’t let that happen.
