- Allowing more than 800,000 square feet of new construction in the Arroyo, around and on top of the Rose Bowl, and ruining the original National Historic Landmark stadium.
- Flooding our streets with football traffic every weekend for half the year, impacting neighborhoods and degrading our quality of life.
- Displacing the Rose Bowl Flea Market and disrupting its schedule.
