## **RECOMMENDATION**

It is recommended that the City Council adopt the following resolution to:

- 1) Approve Final Tract Map No. 54348; and
- 2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

#### **BACKGROUND**

The subject final tract map for the mixed-use project comprised of retail and office spaces and nine residential condominium units at 141 South Hudson Avenue was reviewed and approved in tentative form by the Subdivision Committee on April 9, 2003. A time extension was granted for the subject map by the Zoning Administrator.

The developer's engineer has completed the final map which has been reviewed by the County. Said map is now ready for the City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City, including monumentation. A building permit was issued for the project. No additional discretionary actions were required.

Construction on the project began in May 2004, and is approximately 90 percent completed with the remaining 10 percent tentatively scheduled to be completed in May 2006. The project is being constructed on a parcel that was used as a parking lot. Therefore, the development will not result in the displacement of tenants/renters and is not subject to the Tenant Protection Ordinance, Chapter 9.75 of the Pasadena

# **BACKGROUND** (Continued)

Municipal Code (PMC). The project is also not subject to the standards of the Inclusionary Housing Ordinance, Chapter 17.42 of the PMC, which is applicable to projects of ten or more newly constructed residential units and subdivision maps consisting of ten or more residential lots.

## **FISCAL IMPACT**

The developer has paid for all costs to prepare and process the subdivision documents. Approval of this action will generate additional revenue to the City in an amount to be determined later in the form of property taxes.
