SUBJECT: AWARD OF CONTRACT TO E. C. CONSTRUCTION, FOR CONSTRUCTION OF SITE IMPROVEMENTS AT BROOKSIDE PARK IN THE AMOUNT OF \$310,000

RECOMMENDATION

It is recommended that the City Council:

- 1. Accept the bid, dated April 5, 2006, submitted by E.C. Construction in response to the specifications for Brookside Park Renovation;
- 2. Reject all other bids received; and
- 3. Authorize the City Manager to enter into a contract not to exceed \$310,000.00, which includes the base bid of \$282,995.64 and \$27,004.36 for any additional work the City may order pursuant to the project specifications.

BACKGROUND

This project will implement four Capital Improvement Projects in Brookside Park:

- ADA Compliance Phase V New walkways, drinking fountains, handrails, ramps and picnic facility improvements. These improvements will be made throughout the park.
- Replacement of Walkways Replacement of deteriorated asphalt with new concrete walkways. This work will also occur throughout the park.
- Upgrade Picnic Facilities New decomposed granite surfacing, curbing, drains, barbecues and waste containers. These improvements will be constructed in the group picnic areas on the east side of the park.
- Improve Par Course/Paths New park course equipment, decomposed granite surfacing and curbing. The park course will be in various locations throughout the park.

Plans and specifications for the subject project were prepared by the Department of Public Works.

The project was advertised in the Pasadena Journal on March 9, 2006. In addition, the Notice Inviting Bids was published in three trade publications and two websites. Bid packets were obtained by sixteen contractors, seven of whom submitted bids for the project.

In accordance with Section 4.08.070 of the Pasadena Municipal Code, bids have been requested and received.

Following advertising, bids were received on April 5, 2006 and are as follows:

It is recommended that E.C. Construction be awarded the contract for this project as they are the lowest responsive and responsible bidder and that all other bids are rejected. The proposed contract with E.C. Construction fully complies with the competitive bidding ordinance and the rules and regulations promulgated thereunder as did the Contractor selection process. The Contractor has indicated that the award of this contract will result in no new hires to the present workforce.

The proposed contract with E.C. Construction will be as follows:

Base Bid	\$282,995.64
Contingency Allowance	\$ 27,004.36
Contract "Not to Exceed" Amount	\$ 310,000.00

It is anticipated that construction will begin in May 2006 and be completed in July 2006.

ENVIRONMENTAL REVIEW

Under the State Guidelines for the Implementation of the California Environmental Quality Act (CEQA), this project is categorically exempt since the work consists of minor alterations involving no expansion of use beyond that which currently exists.
