SUBJECT: APPROVAL OF FINAL TRACT MAP NO. 054332, BEING A 12-UNIT

CONDOMINIUM PROJECT, AT 1430 NORTH FAIR OAKS AVENUE

RECOMMENDATION

It is recommended that the City Council adopt the following resolution to:

1) Approve final Tract Map No. 054332; and

Authorize the City Clerk to execute the Certificate on the map showing the City's 2) approval of said map and acceptance of said dedication.

BACKGROUND

The subject Tract Map, being a 12-unit condominium project at 1430 North Fair Oaks Avenue, was reviewed and approved in tentative form by the Subdivision Committee on December 14, 2005.

The developer's engineer has completed the final map which has been reviewed by the County. Said map is now ready for the City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City, including monumentation. A building permit has been issued for the project. No additional discretionary actions are required.

Construction on the project is scheduled to begin in August 2006, and is estimated to be completed in June 2007. The project will be constructed on a site that was previously developed with a 1,000 square foot commercial structure that was demolished. The project will result in an increase to the City's housing stock. The project is a residential development with a Density Bonus of two units. The developer has entered into an Inclusionary Housing Density Bonus Ownership Agreement, which is being recorded by the Los Angeles County Recorder. As such, this development has complied with standards of the Inclusionary Housing provisions Pasadena Municipal Code Title 17, Chapter 17.42. The project will not be subject to the Tenant Protection Ordinance - Pasadena Municipal Code (PMC) Chapter 9.75.
