SUBJECT: AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF PASADENA TO ESTABLISH EDUCATIONAL USES AT ART CENTER COLLEGE OF DESIGN (SOUTH CAMPUS)

TITLE OF PROPOSED ORDINANCE

AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 17 (THE ZONING CODE), ARTICLE 2 (ZONING MAP) TO REZONE AREAS OF THE SOUTH FAIR OAKS SPECIFIC PLAN (ART CENTER COLLEGE OF DESIGN, SOUTH CAMPUS) AND ALLOW EDUCATIONAL AND DORMITORY USES

PURPOSE OF ORDINANCE

This ordinance implements and codifies the Zoning Map amendment approved by the City Council on January 30, 2006, to amend the zoning applicable to the Art Center College of Design's South Campus, and allow educational and dormitory uses.

REASON WHY LEGISLATION IS NEEDED

This legislation is needed to maintain consistency between the City's General Plan and the South Fair Oaks Specific Plan. This legislation supports General Plan Objective 23, which states that the City shall provide long-term opportunities for growth of existing educational institutions, among others, in balance with their surroundings. This legislation also supports General Plan Policy 23.4 to support Specific Plans, master plans, and other planning activities instituted by educational institutions, among others.

PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED

The Planning and Development Department will implement the proposed ordinance through modifications to the Zoning Map and processing of subsequent building requests on the affected properties.

AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 17 (THE ZONING CODE), ARTICLE 2 (ZONING MAP) TO REZONE AREAS OF THE SOUTH FAIR OAKS SPECIFIC PLAN (ART CENTER COLLEGE OF DESIGN, SOUTH CAMPUS) AND ALLOW EDUCATIONAL AND DORMITORY USES

The People of the City of Pasadena ordain as follows:

SECTION 1. The official map of the City of Pasadena as established by Title 17,

Chapter 17.20, Section 17.20.020 of the Pasadena Municipal Code is amended by modifying the

boundaries of certain zoning districts established therein as follows:

By reclassifying from IG-SP2-HL56 (Industrial, South Fair Oaks Specific Plan, Height

Limit 56 feet) to PS (Public and Semi-Public) as shown on the map entitled "Art Center College

of Design South Campus Zone Change" attached hereto as Exhibit A and incorporated herein by

this reference as if fully set forth herein, and on file in the City Clerk's Office.

SECTION 2. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.

SECTION 3. This ordinance shall take effect 30 days from its publication.
