Dear Mayor Bogaard and Members of the City Council:

We write you on behalf of La Salle High School ("La Salle"). We ask that following the public hearing currently scheduled for Monday, October 16, 2006, you approve La Salle's application for a conditional use permit to install lights on La Salle's existing athletic field.

1. The Lighting Facilities. La Salle proposes to install a total of four (4) light poles, each with a maximum height of 80'—approximately the same height as the flag poles in front of City Hall. Two (2) of these poles would be located on the north side of the field—adjacent to the parking lot and Sierra Madre Boulevard, and two (2) would be located on the south side of the field, with the lights aimed away from residential areas to the south. Musco Lighting, which is the premier firm in the sports lighting business, has been hired to install the lights, using state-of-the-art technology to eliminate unwanted light spillage.

2. Restrictive Schedule of Light Usage. The hearing officer in this matter approved La Salle's CUP Application, adopting the following restrictive annual schedules of light usage (which La Salle has accepted):

a. Football games on up to six (6) Friday nights, from 5:00 p.m. to 10:00 p.m. (with the possibility of three (3) more games if La Salle's team qualifies for the CIF playoffs).

b. Soccer events, Monday through Friday, from 5:00 p.m. to 7:00 p.m. (not to exceed 40 evenings).

c. Two (2) track events, from 5:30 p.m. to 6:30 p.m.

- d. No lights on Saturday or Sunday.
- e. No more than three (3) lighted events per week after the football season.
- f. No use of lights from April 1 through August 25.
- g. No use of the athletic fields on Sundays.

Under these restrictions, the lights would be used only sparingly, compared with over 8,700 hours of possible usage in a year. Such restrictive scheduling more than protects the immediate neighbors from perceived burdens.

3. No Significant Use Intensification. The approval of the proposed lights will not lead to any significant intensification of the use of the athletic field. La Salle currently uses this field for football, soccer and track meets. For obvious reasons, these events are currently scheduled during the daylight hours. In connection with the current usage, La Salle already has in place procedures to deal with noise, traffic and parking issues. Use of the proposed lights will merely allow La Salle to play football games at night and use the lights for late afternoon soccer and track events, as needed. Suggestions of significant adverse environmental impacts from such uses are baseless.

4. Friday Night Lights. Balanced athletic programs are an important component of a quality educational institution. La Salle hopes to enhance its already fine reputation by participating in the great American tradition of Friday night football on its home field. Nearly every major high school in the area has its own lighted athletic field. By way of example, the following local high schools have their own lighted fields: La Cañada, St. Francis, South Pasadena, San Marino, Arcadia, Pasadena and Muir, and many more. Indeed, just last year the City of Pasadena approved the application of Maranatha High School for a lighted athletic field on the West Ambassador College Campus, essentially without any restrictions whatsoever other than a 10:00 p.m. curfew.

5. Light Poles In Urban Setting. You might question whether the light poles themselves would constitute a significant adverse environmental impact. We believe they will not. In an urban setting such as Pasadena, poles and lights of all shapes and sizes are part of the environment. In the Hastings Ranch area, there already exist the following types of poles: street lights on every roadway, especially along Sierra Madre Boulevard; stop lights at major intersections; telephone and power poles along the rear property lines of all homes; commercial signage at the Hastings Ranch Shopping Center; cell towers in church parking lots; tall trees are common throughout the area; and existing light poles at all city parks, especially Victory Park and Hamilton Park. In addition, La Salle has agreed to install special fencing and landscaping along its southern property line to buffer the area and create greater privacy for the neighbors. La Salle did investigate the possibility of using retractable poles, but except for specialized



extension poles with portable trucks, the technology does not currently provide for such telescoping.

6. Children Should Be Our Top Priority. Pasadena has for many years proclaimed that children are our first priority. Indeed, City Council chambers recently had a banner to this effect. We are aware that this application for a lighted athletic field has created tensions between La Salle, on the one hand, which is attempting to provide its students with a well-balanced, quality curriculum, and some surrounding neighbors, on the other hand, who fear possible nighttime annoyances. Given the proposed conditions of approval, however, we believe those competing interests are properly balanced, thereby allowing the City Council to approve this application and give true priority to the children of our area.

Based on the foregoing, we feel that La Salle's application to install lights on its athletic fields is appropriate and should be approved.

Mayor Bill Bogaard and the Pasadena City Council,

Think back if you will to the days of our youth. The innocents of our high school relationships and of our camaraderie propelled by our high school teams. Our "home town" teams meant teams of families in support of teams of players.

For myself I have vivid memories of late summer Friday evenings in New England. Although only a spectator (5 feet tall as a freshman and not much more when I graduated), I recall sitting with my father and bothers watching "our" team beat cross town rivals on "our" turf. The excitement of those "Friday night lights" lasted a lifetime, and I am very much looking forward to experiencing this again with my family, but in the role of the parent.

To have several outspoken "neighbors" concern themselves regarding the prospects of a handful of night games (finishing by 10 pm), is in my humble view, over-reactive. To have these several members sit on the Board of Zoning Appeals and unfairly rule that La Salle cannot erect lights is unjust, and a misappropriation of their function. To have the Pasadena City Council correct the errors that this seemingly lopsided board propagated, is justified.

I support La Salle High School and ask the Pasadena City Council correct the errors of the Board of Zoning Appeals and allow La Salle High School to install lights on our athletics fields.

I have a 9th grade son at La Salle High School, and two other children right behind him. He's not a football player (I'm afraid he received my vertical genes), but a water polo player. But more than that, I see the closeness to the school and the bonds of friendship already being forged. I do not want them to miss an opportunity for a fond memory that for us as adults we may have taken for granted.

Thank-you for your consideration, and I look forward to your response and appropriate action on the October 16th hearing.
