Dear Mayor Bogaard and City Council Members,

I attended the mediation meeting on August 19, 2006 with Councilmen Little and Holden. Councilman Little immediately conveyed that the application for the vacation/easement would be granted and he and Councilman Holden were present to mediate the differences between the neighbors and John Quinn.

The neighbors had previously elected Attorney Chat Pratt to act as their mediator and carry out the charges set forth at the council meeting on August 14, 2006. Any type of a defined mediation was dismissed by Councilman Little, (there was no mediation.)

The meeting was moved to Madia Street and some concessions were made at the site. One of the concessions was the ash tree would be removed by a vote of the council, so the cul-de-sac could be moved east at least twelve feet of the present configuration, so Quinn's driveways open onto the street and not the cul-de-sac. That statement was included on the August 21, 2006 Resolution of Issues, # 7 to Councilman Holden and John Quinn from Councilmanl Little and copied to Mr. Bishop, not our Attorney Chad Pratt. A new copy was distributed on September 5, 2006 and again on September 20, 2006 with # 7 excluded.

I have contacted Dan Rix on three occasions and our Attorney Chad Pratt and I have also met with John Samarin, Gil Weiss, both employees of the city engineering department and ask them to draft a map that would include #7. As of today, October 23, 2006 a.m., I have not received a map including driveways outside the bubble of the cul-de-sac. It should be noted that Dan Rix has told me it can not be done, and he was not instructed by Councilman Little to remove the driveways from the cul-de-sac.

Because of the lack of cooperation of the engineering department, and Councilman Little having knowledge of the # 7 breach and not demonstrating an effort to correct a very important issue of the neighbors, I am casting my vote not to allow the vacation/easement.
