**SUBJECT:** AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTIONS 9.36.220 AND 9.36.230 OF THE PASADENA MUNICIPAL CODE RELATING TO LIMITATIONS ON HOURS OF OPERATION OF AMPLIFIED SOUND ON A SUNDAY FROM 9:00 AM – 10:00 AM AND NOISE SOURCES FOR THE LUNAR NEW YEAR PARADE & FESTIVAL, A PERMITTED EVENT, IN OLD PASADENA AND AT CENTRAL PARK FROM 9:00 AM – 5:00 PM ON SUNDAY, FEBRUARY 18, 2007.

**TITLE OF THE PROPOSED ORDINANCE:**

AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTIONS 9.36.220 AND 9.36.230 OF THE PASADENA MUNICIPAL CODE RELATING TO LIMITATIONS ON HOURS OF OPERATION OF AMPLIFIED SOUND ON A SUNDAY FROM 9:00 AM – 10:00 AM AND NOISE SOURCES FOR THE LUNAR NEW YEAR PARADE & FESTIVAL, A PERMITTED EVENT, IN OLD PASADENA AND AT CENTRAL PARK FROM 9:00 AM – 5:00 PM ON SUNDAY, FEBRUARY 18, 2007.

**PURPOSE OF ORDINANCE:**

This proposed ordinance will temporarily suspend the hours of operation for amplified sound equipment allowed by the City's Noise Ordinance on Sundays by non-profit organizations from 9:00 a.m. to 10:00 a.m. for a permitted event in Old Pasadena and at Central Park during specified hours on Sunday, February 18, 2007. The enactment of this proposed ordinance is needed for this event to take place.

The City Council is considering approval of this request and holding the first reading of same at the September 11, 2006 City Council meeting.

**REASON WHY LEGISLATION IS NEEDED:**

The Noise Ordinance was enacted by ordinance and can only be suspended by an ordinance of the City Council.

**ENVIRONMENTAL IMPACT:**



This action to allow the Lunar New Year Parade is normal operation for public gatherings in Area H.

AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTIONS 9.36.220 AND 9.36.230 OF THE PASADENA MUNICIPAL CODE RELATING TO LIMITATIONS ON HOURS OF OPERATION OF AMPLIFIED SOUND ON A SUNDAY FROM 9:00 AM – 10:00 AM AND NOISE SOURCES FOR A PERMITTED EVENT TO BE HELD IN OLD PASADENA AND CENTRAL PARK ON SUNDAY, FEBRUARY 18, 2007 (THE LUNAR NEW YEAR PARADE & FESTIVAL).

The People of the City of Pasadena ordain as follows:

SECTION 1. Sections 9.36.220 and 9.36.230 of the Pasadena Municipal Code are hereby suspended from the hours of 9:00 a.m. to 10:00 a.m. on Sunday, February 18, 2007, for an event in Old Pasadena and at Central Park for which there is a Special Event Permit in force and effect.

SECTION 2. The City Clerk shall certify the adoption of this Ordinance and shall cause this ordinance to be published in full text.

SECTION 3. This ordinance shall take effect upon its publication.


