My name is Randall Gorden and I am writing to you as a representative of the Gorden Families in the City of Pasadena, a family of multiple families and generations.

I would like to urgently ask you as a representative of my city, Pasadena – to present our objection to the proposed development of the Adult Strip Club being considered and reviewed for the former Shakey's Pizza Location at 2180 East Foothill Boulevard.

I would also like to urge you to support the efforts of our City Council Member, Steve Haderlein in establishing reasonable protections for neighborhoods and schools with at least a minimum distance from residences and schools and a limitation on the number of these types of businesses in one area.

While the Gorden families advocate for the elimination of all sexually exploitative Adult Entertainment establishments within the borders of Pasadena, we also strongly support the efforts of Council Member, Steve Haderlein in his proposals on establishing limitations and rational protections towards such establishments which already exist in a large majority of neighboring cities.

Pasadena is unique in that compared to local surrounding cities, we have a certain level of excellence that has existed since its incorporation. I will not go on and on about the OBVIOUS issues here, but I want to bring one very important additional fact to your attention: is anyone aware that the Champion Gymnastics facility is in the same block as Shakey's? This facility is home to the #1 gymnastics program in the San Gabriel valley, serving girls age 4 - 18+ (or so), attracting females from Pasadena, La Canada, San Marino, Arcadia, Glendale, and other towns. My daughter takes lessons at Champion Gym (behind Marie Calendars), and I am not happy at all with the thought that there could be a strip club in the same block. It's like allowing it to open next to a girls' school. I attended Westridge, and I don't think a strip club would be allowed near them.

I am writing concerning the proposed development of a "strip club" at the location of the closed Shakey's Pizza restaurant on Foothill Blvd. This is an exceedingly poor location for such a business in that it is located between a veterinary hospital and a dog day care and boarding facility. Both of these businesses are regularly frequented by children accompanying their parents.

Let me be clear, I do not oppose sexually-oriented businesses that are legally sanctioned. However, their location must be carefully regulated. I am the co-owner of Foothill Veterinary Hospital, which neighbors the proposed strip club at 2180 E. Foothill Blvd. I am very concerned about having a strip club next to my animal hospital. I fear that it will have a negative impact on our business as well as our community service programs.


Foothill Veterinary Hospital is a very busy small animal hospital that has been serving the community since 1951. Many of our clients have been patrons of our hospital for years over several generations. We have many senior citizen clients, as well as clients with children. We have already received phone calls from concerned clients. They have stated that, although they value us as their veterinarians, they do not want to bring their children near a strip club, or the patrons of such a business. If we do not stand against the strip club, even our loyal clients may feel the need to go elsewhere for their veterinary services.

We also offer tours of our facility to local school children (K-6 grade). During the school year we average 2-3 tours a week. If a strip club or "adult store" is opened next to our hospital we may be forced to discontinue this community program. I am sure the schools and parents would not approve of the children going on a tour right next door to a strip club. Furthermore, we are a teaching hospital. Each year, from August through May, we host 3^{rd} -year veterinary students from Western University on a full-time basis. Although these are adult students, I feel that the University would not approve of sending them to a facility that is right next door to a strip club.

I feel that these reasons, besides my own personal feelings on the situation, are all important reasons to contest the opening of this new business. I appreciate your time and attention, and welcome the opportunity to discuss this matter further. I can be reached at 626-792-1187. Thank you.
