SUBJECT: LICENSE AGREEMENT WITH THE KSCI CHANNEL 18 TO CONDUCT THE LUNAR NEW YEAR PARADE & FESTIVAL

RECOMMENDATION:

It is recommended that the City Council:

- Acknowledge that the proposed Lunar New Year Parade & Festival License Agreement and lifting of the Noise Ordinance are categorically exempt under California Environmental Quality Act (CEQA) Guidelines Section 15323 Normal Operations for Public Gatherings and;
- Approve an ordinance to suspend the Noise Ordinance by permitting amplified sound on a Sunday beginning at 9:00 am and Notice of Exemption and hold the first reading of same on Monday, September 11, 2006, with respect to the Lunar New Year Parade & Festival to be held in Old Pasadena and Central Park on Sunday, February 18, 2007 and;
- 3. Authorize the City Manager to enter into a license agreement according to the business points set forth in the body of the agenda report with KSCI Channel 18 and;
- 4. Direct the City Clerk to file the Notice of Exemption with the Los Angeles County Registrar-Recorder/County Clerk.

BACKGROUND:

The Lunar New Year Parade & Festival is a free, cultural event that honors and celebrates the Pan-Asian community's culture and customs. The event features a parade through Old Pasadena beginning at 10:00 am followed by a festival at

Central Park ending at 5:00 pm. The event features entertainment, floats, cuisine, children's activities, and contests.

KSCI's Lunar New Year Parade & Festival previously raised money for the Pasadena-based Kultura Philippine Folk Arts Association. KSCI has expanded their local partnership to include a commitment for marketing support to the Old Pasadena Management District and monetary and in-kind donations to the Pasadena-based non-profit Friends of the Castle Green.

ANALYSIS:

On December 12, 2005, Council adopted the "Policy for Large Events in Public Parks" which defines a large event at Central Park as one that would host a maximum of 4,600 people at one time. The projected attendance for the Lunar New Year Parade & Festival is 6,000 people throughout the course of the day.

Council may waive these limits by approving a license agreement when they believe it is in the best interest of the community.

A suspension of the Noise Ordinance Section 9.36.220 (amplification sound regulations) and 9.36.230 (general noise sources) of the Pasadena Municipal Code is also required in order to conduct sound checks for the parade prior to 10:00 am. The lifting of the Noise Ordinance for this event would permit amplified sound at 9:00 am. The applicant is not seeking a waiver of the entire Noise Ordinance. Sound from the event will be consistent with the Noise Ordinance and will be monitored.

This event was held in previous years at the same location and posed no additional disturbance to surrounding neighbors that was not able to be resolved nor were there any additional public safety issues.

License Agreement

The following are the major business points for the license agreement:

- This would be a three year license agreement between the City and KSCI to produce their Lunar New Year Parade & Festival in Old Pasadena and at Central Park on February 18, 2007 and the date that Lunar New Year falls in each succeeding year of the agreement. The date of Lunar New Year is determined by the Chinese calendar and KSCI's event typically falls on the 1st day of the Lunar New Year week which is usually in February.
- 2. KSCI agrees to produce an on-air television promotion for Old Pasadena Management District and the event as a cultural destination and experience and annually provide monetary and in-kind donations to the Friends of the Castle Green in an amount equivalent to the rate KSCI pays for the park rental.
- 3. No tobacco or hard alcohol products of any kind would be used as a name sponsor or in any advertising.

- 4. KSCI will not hold the City responsible for the success of the Lunar New Year Parade & Festival.
- 5. The City would co-sponsor the event by calculating park rental rates at a non-profit rate based on KSCI's partnership with the Friends of the Castle Green, a Pasadena-based non-profit and the City logo would appear in all event promotional materials.

Environmental Analysis

Staff reviewed the project and determined that it is categorically exempt under CEQA Guidelines Section 15323, normal operations of Facilities for Public Gatherings.

FISCAL IMPACT:

Any City costs that may be incurred, (i.e. sound meter reading, police and fire personnel, permit costs, park clean-up, etc.) are to be paid by KSCI. The estimated permitting costs for this event are \$28,496.

KSCI has applied for a license agreement to hold their event at Central Park thereby exceeding the large scale event attendance thresholds at Central Park established by the Park Policy adopted in December 2005. A suspension of the Noise Ordinance Section 9.36.220 (amplification sound regulations) and 9.36.230 (general noise sources) of the Pasadena Municipal Code is also required in order to conduct sound checks prior to the start of the parade.

Dear Ms. Shimazu:

It is with great pleasure and with wholehearted support that the Friends of the Castle Green (Friends) accept the role of City of Pasadena non-profit partner for KSCI-TV's annual Lunar New Years Parade and Festival in Old Pasadena. This parade follows in a great tradition, and the Friends are pleased that the annual Lunar New Years Parade & Festival have become yet another tradition in Pasadena. You may also know that the other famous parade in Pasadena was founded by an organization based at the original 1890's Hotel Green, of which the Castle Green was the West Annex expansion in 1898. So it is fitting that the Castle Green, through the Friends becomes involved yet again in a new, and hopefully lasting tradition. And with the hopeful extension of the Parade south on Raymond Avenue to Central Park, this takes the parade route in front of the Castle Green, as did the early Tournament of Roses parades.

Over the three-year term of this partnership, the Friends will receive in-kind support and/or monetary support from KSCI-TV. That support could be as simple as promotion of the two annual fundraising tours that the Friends sponsor at the Castle Green, and/or possibly some level of financial contribution to the Friends in support of their mission, which is to preserve and restore the historic Castle Green as a local, state and national landmark.

Your help in promoting the annual tours would be of great value to the Friends. Each tour typically raises \$8,000 - \$15,000 or more, with virtually all funds raised earmarked for restoration projects at the Castle Green. Within the last five years, the Friends have spent almost \$50,000 on restoration projects at the Castle Green, among them: a) painting of the "Bridge" above the entry to the Castle Green; b) a portion of the Hotel Green Carpet restoration project; c) t he recent restoration of the original arched colonnade and lobby at the Penthouse. The Friends currently have earmarked funds for the completion of the Verandah Roof Restoration Project, involving manufacturing and installation of unique-sized, newly manufactured terra cota roof tiles per the Secretary of Interior Standards as required by our landmark status.

Of course, any additional support such as tour advertising in other media or direct financial contributions to the Friends would multiply the benefits to this National Register landmark and to the Pasadena community at large.

Pasadena is known for opening its arms to the world and for multi-culturalism, and the chance to support another annual "New Years" parade is something that the Friends gladly welcome. With that support, however, comes an expectation of responsibility to respect Central Park, The Castle Green has vigorously defended the park, causing the City of Pasadena to reevaluate the use of all parks for large events. Outside of the Christmas and Thanksgiving holiday feeding of the homeless at the park, these are the only events -- both parade and festival -- that are supported at Central Park. But having personally observed the first two Lunar New Years events, and the care taken to respect Central Park, the Friends are confident that this is not only an appropriate activity for the area, but one that will foster improvement in the area, and will be good for Old Pasadena as well.

The Friends are excited to be chosen by KSCI-TV as their partner in this world-class event. We look forward to a long and prosperous relationship with benefit to all.
