Dear Mr. Madison, Mayor Bogard, and Council Members:

I would like to thank Mr. Madison very much for the informative and enjoyable interview he granted me, Ann Scheid, and others on April 2.

It was a great pleasure to discuss with him our thoughts about the Desiderio site. I understand there were subsequent meeting with Ms. Scheid, neighbors and other members of the Council and the Mayor. We appreciate all you time and effort.

Since our meeting with Mr. Madison the neighborhood and the West Pasadena Residents Association have united in our support of the Planning Commission's unanimous proposal.

We know that the Planning Commission worked for over six months on that proposal. We know that the Commission thought through all the issues.

I would point out that the City Council ratified the proposal of the Planning Commission at your meeting just prior to the special meeting called two weeks ago.

The Commission's long and thoughtful work and your ratification of that work has suddenly been cast aside in favor of what you yourself characterize as a proposal you have "cobbled together." In other words, months of planning and voting is being thrown away in favor of a hastily concocted split-the-baby hodge-podge which lacks neighborhood support.

The Planning Commission's proposal had two key components: (1) space controlled by Habitat – 25% of the site; (2) open space owned and controlled by the City – 75% of the site.

My recommendation is that you propose the Council re-ratify those two elements and present it to the Federal Government with the truthful representation that the proposal has broad community support.

Leave the rest out. Do not commit to anything further.

What about the buildings? They obviously sit on the Open Space.

Should they be destroyed? Should they be modified? Re-configured? Who should have control of them? Should another building be built on the site?

I like almost all my neighbors, Ms. Scheid, the WPRA, and the Planning Commission all think the old buildings should come down.

We would be most happy if you decide right now that you agree. We would be even happier if a majority of the Council supports that view.

However, I, speaking for myself alone, believe you don't have to decide this at this time. You could go with the two basic principles of the Planning Commission's proposal (1) Habitat and (2) Open Space.

You could characterize the buildings as part of the Open Space. You could leave their fate up to the City and the Community to be decided with more thought and consideration by the Planning Commission, the neighbors, the WPRA, the two entities currently bidding for the buildings, and other entities who would probably come forward if the buildings were deemed to be worth saving.

Probably the biggest problem with this plan is that the buildings may interfere with Habitat's use of the site. Then, let that be the City's primary consideration after the City has been given control of the site by the Federal Government. If Habitat says a building or buildings or part of a building needs to come down to maximize their nine dwellings on whatever 25% will suit them best, then the City should accede to Habitat's request.

Habitat has compromised from twenty dwellings to nine and from the whole site to 25%. Habitat is a well funded organization with years of public service and broad community support. Let Habitat decide the 25% of the site which is best for its nine houses. Let Habitat tell the City if Habitat sees a need for demolition of part or all of a building.

The City's position of control of the buildings without commitment as to their fate will give the City maximum flexibility both with respect to Habitat's 25% of the site and the City's 75% open space.

I believe I have argued correctly and persuasively for a Plan which is consistent with the Planning Commission's proposal, the Council's previous vote, and the wishes of a majority of the citizens of Pasadena.

Why not commit to the Art Club and the Arroyo Seco Foundation? Are there other reasons besides those articulated above? Yes there are.

The Foundation has already been granted use of buildings and space at Hahamunga. The Foundation specifically asked that buildings be saved at Hahamunga for the Foundation's use. There is no neighborhood to protect at Hahamunga. Hahamunga is already controlled by the City. As soon as the Foundation has the financial wherewithal to remodel, build, and occupy, the City could give the green light and the Center for the Environment could become a reality.

The Art Club is approximately 100 years old. It is an organization which supports the arts. Who could not be in favor of the Art Club?

I for one question the bonafides of the Art Club. I question its financial footing. I believe that the club has less than \$20,000 in current assets. If a school, gallery, and permanent offices are so important to the Art Club, why hasn't the Club raised money and bought or built its own space to accomplish these goals. Its 100 year history is presented to the community as a plus. But I see 100 years with no fund raising, no real presence in the Pasadena community and no building.

I accept that the site under the bridge has a romantic and artistic appeal to plein air artists and lovers of art. However, the City already owns a spot La Casita which the Club could use for classes and shows – right there on the Arroyo. If the club had done this or were to do so in the future, this would go a long way to convince me and others that the Club really cared about the Arroyo, the Bridge, and this location. Unfortunately, I have lived on Arroyo Boulevard for five years and during that time I have not seen the Club do anything to show its love of our location.

In conclusion, you have a good plan which you have already adopted. Just stick with the basics of that plan: 25% Habitat and 75% open space. Accept that the buildings are sitting on the open space. Defer on final disposition of the buildings depending on input from Habitat and others after the City has control of the site. Recognize that the Foundation already has a good spot for their Center. Recognize that the Art Club's vision for the site may not be consistent with the neighborhood but also recognize that deferring final decision regarding the existing buildings or new building on the open space does not rule out anything the Art Club has proposed.
