**SUBJECT:** AUTHORIZE PURCHASE ORDER WITH ROAD RESCUE FOR

PURCHASE OF THREE RESCUE AMBULANCES FOR A TOTAL OF

\$450,521

### RECOMMENDATION

It is recommended that the City Council

- 1) Authorize the issuance of a purchase order to Road Rescue in an amount not to exceed \$450,521 for the purchase of three Rescue Ambulances; and
- 2) Grant the proposed purchase order an exemption from competitive bidding pursuant to City Charter section 1002(H), contracts with other governmental entities or their contractors for labor, material, supplies or services.

### **BACKGROUND**

The Pasadena Fire Department needs to replace two emergency rescue ambulances: equipment #0951, a 1999 model stationed at Fire Station 31; and #0952, a 1999 model stationed at Fire Station 36. The established lifecycle for a rescue ambulance is six years. These emergency vehicles have met or exceeded their useful lifecycle, have over 240,000 miles collectively, and are no longer economical to maintain. The vehicle replacement/condition report is attached.

The third ambulance was approved by the City Council as part of the Fire Department's FY2007 operating budget. This new rescue ambulance will establish the City's fifth ambulance staffed on a 24/7 basis and improves the City's EMS response. This purchase will also bring the average age of the fleet down to three years from the current seven years old, giving the Pasadena Fire Department a more reliable fleet of EMS vehicles.

The City of Carlsbad currently has a contract in place with Road Rescue for the purchase of two Rescue Ambulances. Road Rescue has offered to extend this contract price to the City of Pasadena for three ambulances in FY2007. By taking advantage of this opportunity the City will realize cost savings of approximately \$10,276 based on vehicle pricing as of January 2007. Additionally, the ambulances purchased by the City of Carlsbad are the same build configuration as the last two ambulances purchased by

Pasadena. Continuing to purchase units with this configuration will help to reduce both repair costs and vehicle downtime due to parts standardization and mechanic familiarity with the equipment.

### **FISCAL IMPACT**

Two ambulances are a budgeted replacement and sufficient funds are available in the Equipment Replacement Fund, account #8505-503-766300.

The third ambulance will be purchased using account #8505-101-363200 of the Fire Department, as approved in the Department's FY 2007 budget.
