SUBJECT: CONTRACT AWARD TO INSITUFORM TECHNOLOGIES, INC. FOR 2007 SEWER RELINING FOR AN AMOUNT NOT TO EXCEED \$261,000

RECOMMENDATION

It is recommended that the City Council accept the bid, dated February 28, 2007, submitted by Insituform Technologies, Inc. for the 2007 Sewer Relining, reject all other bids received, and authorize the City Manager to enter into such contract as is required.

BACKGROUND

The project calls for the installation of 7,000 feet of pipe liner inside vitrified clay and cast iron sewer pipes at various sites throughout the City, as shown in Exhibit 'A'. These locations were identified during Phases 1 and 2 of the five-year sewer televising program. The liner is being installed to eliminate defective joints in the sewer pipes, which allowed severe root intrusion. Rehabilitation of the pipes will be accomplished with the insertion of pipe liner via the sewer manholes. There is no excavation required for this process, so the inconvenience to the public will be minimal. On those streets with high daytime vehicular traffic, or in pipes with heavy daytime sewer flow, the work will be done at night. This project is consistent with the Land Use Element by continuing to implement capital improvements which will maintain or rehabilitate infrastructure.

The Department of Public Works prepared Plans and Specifications for the subject project. In accordance with Section 4.08.070 of the Pasadena Municipal Code, bids have been requested and received. The project was advertised in the <u>Pasadena</u> <u>Journal</u> on February 1, 2007. In addition, the Notice Inviting Bids was published in four trade publications, listed on two web sites, and mailed out to forty-nine potential bidders. Bid packets were obtained by four contractors, three of whom submitted bids for the project.

Following advertising, bids were opened on February 28, 2007 and are as follows:

It is recommended that Insituform Technologies, Inc. be awarded the contract for this project as they are the lowest responsive and responsible bidder. The proposed contract with Insituform Technologies, Inc. fully complies with the Competitive Bidding and Living Wage Ordinances. The Contractor has indicated that the award of this contract will result in zero new hires to his present workforce.

The proposed contract will be set up as follows:

Base Bid	\$ 237,255.00
Contingency Allowance	23,745.00
Contract "Not to Exceed" Amount	\$ 261,000.00

It is anticipated that the project will begin in May 2007 and be completed in July 2007.

Funds for this project are available in Capital Improvement Budget Account 76267, Preventative Maintenance – Sewer System.


