SUBJECT: COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM CITY SET-ASIDE RECOMMENDATION (2007-2008)

RECOMMENDATION

It is recommended the City Council approve the 2007-2008 Community Development Block Grant (CDBG) Program City Set-Aside of \$1,638,133 with an allocation of \$839,000 to four eligible City administered projects and \$799,133 to two mandatory projects (Section 108 Loan Repayment and CDBG Program Administration).

BACKGROUND

The CDBG 2007-2008 program budget is \$2,480,199 (Annual Entitlement of \$2,280,199; and \$200,000 in current year program income). The recommended 2007-2008 City Set-Aside is for six (6) non-public service projects in the amount of \$1,638,133 as listed below:

(3) Maintenance Assistance Services to Homeowners (MASH)	\$500,000
(4) Business Development (Job Fairs)	\$30,000
(5) Section 108 Loan Repayment	\$332,279
(6) CDBG Program Administration	\$466,854
Total	\$1,638,133

All proposed projects meet the local and U. S. Department of HUD defined threshold requirements. Each project complies with the established funding priorities and represents continued funding of prior year's projects. Additionally, the MASH Program will receive supplemental funding in the amount of \$100,000 from the Housing Opportunity Fund to maintain the total project funding at \$600,000.

Exhibit "A" provides information regarding the projects' recommended funding, prior year funding, and brief project descriptions.

Upon approval of the recommended CDBG City Set-Aside (\$1,638,133) \$842,066 remains available for the Commissions to allocate (Human Services Commission \$370,279 and Northwest Commission \$471,787).

CHILDREN, YOUTH AND FAMILY IMPACT

It is anticipated that approval of the above mentioned recommendation will provide economic development activities, housing rehabilitation, code enforcement activities, etc. Services provided through these programs will have a positive impact on the quality of life for local children, youth and families.

FISCAL IMPACT

The funds referenced in this report are federal dollars. Approval of the subject recommendation will augment services currently being provided by the City. There is no fiscal impact to the City's General Fund as a result of this action.
