SUBJECT: APPROVAL OF AN AMENDMENT TO THE EMPLOYMENT CONTRACT  
WITH CITY CLERK JANE L. RODRIGUEZ

## RECOMMENDATION

It is recommended that the City Council approve the attached Amendment to Contract No. 17,605, the Employment Agreement between the City of Pasadena and City Clerk Jane L. Rodriguez, effective February 5, 2007; and approve a journal voucher appropriating the necessary funds from the Personnel Reserve to the FY 2007 Operating Budget.

## BACKGROUND

In April 2001, the City entered into an Employment Agreement with the City Clerk that provides for a periodic salary review. The attached Amendment to the Agreement provides for a 10% salary increase effective September 4, 2006.

## FISCAL IMPACT

The fiscal impact of this amendment is estimated to be approximately \$15,000 annually.

**CONTRACT NO. 17,605 - 3**

**THIRD AMENDMENT TO THE EMPLOYMENT AGREEMENT BETWEEN THE CITY OF PASADENA AND CITY CLERK JANE L. RODRIGUEZ**

THIS AMENDEMENT TO AGREEMENT is entered into on February 5, 2007, by and between the CITY OF PASADENA, a municipal corporation of the State of California, herein referred to as "CITY," and Jane L. Rodriguez, herein referred to as 'EMPLOYEE.'

**RECITALS:**

WHEREAS, CITY and EMPLOYEE entered into Contract No. 17,605 on April 30, 2001 ("the Employment Agreement"), setting forth the terms of EMPLOYEE'S service as City Clerk of CITY; and,

WHEREAS, it remains the desire of CITY to continue to retain the services of EMPLOYEE as City Clerk and the desire of EMPLOYEE to serve in that capacity; and,

WHEREAS both parties desire to modify certain terms of the Employment Agreement;

NOW, THEREFORE, the parties hereto agree to amend the Employment Agreement as follows:

1. Section IIIA is amended to provide that EMPLOYEE'S base salary shall be increased to \$137,933 effective September 4, 2006.
2. All other terms and conditions of Contract No. 17,605 not modified herein shall remain in full force and effect.


