JOINT USE SCHOOL/PARK SITE STUDY

On December 4, 2006, the Public Safety Committee considered the Joint Use School/Park Site Study prepared by staff. The Committee adopted the recommendations of staff with the following additions:

- 1) Direct City staff to work with the School District to prepare an agreement for the use of McKinley Elementary School as a Joint Use School/Park Site and City staff prepare a cost estimate and scope of work for implementation of improvements to meet school/park site criteria. Approved but added the following request: Prepare detailed comprehensive cost estimates for all seven school sites presented in the Joint Use School/Park Site Study including maintenance and security costs within 90 days.
- 2) Direct City staff to work with the School District to prepare an agreement for the use of tennis courts by the public after hours and weekends at Blair High School, Pasadena High School, Marshall Fundamental School and McKinley Elementary, which includes the cost of court resurfacing as necessary. Approved but added the following request: Prepare detailed cost estimates and other improvement options for tennis courts at Wilson Middle School within 90 days.

**SUBJECT:** JOINT USE SCHOOL/PARK SITE STUDY

## RECOMMENDATION

It is recommended that the City Council:

- 1) Direct City staff to work with the School District to prepare an agreement for the use of McKinley Elementary School as a joint use School/Park site and City staff prepare a cost estimate and scope of work for implementation of improvements to meet park/school site criteria; and
- 2) Direct City staff to work with the School District to prepare an agreement for the use of tennis courts by the public after hours and weekends at Blair High School, Pasadena High School, Marshall Fundamental School and McKinley Elementary, which includes the cost of court resurfacing as necessary.

### BACKGROUND

At the July 10, 2006, meeting of the Public Safety Committee and the Pasadena Unified School District (PUSD) Facility and Capital Project Committee, discussion occurred on the expansion of the Madison School/Park model to other sites within the City. The Public Safety Committee asked staff to evaluate various school sites, as well as evaluate various tennis courts at school sites to determine the viability of opening these facilities to public use after school hours and on weekends. Attached is the preliminary review of the sites along with a matrix indicating the cost and timing for activating each of these sites.

Staff has utilized this matrix along with a map contained in the Draft City Park Master Plan indicating green space gaps in the City as the basis for this recommendation. In addition, staff examined the existing project construction workload to determine the feasibility of implementation in the identified timeframe.

## **FISCAL IMPACT**

The preliminary review has shown a cost of approximately \$100,000 to make available McKinley Elementary School as a School/Park site. The cost of resurfacing the tennis courts is approximately \$4,500 per court, which could add 19 additional courts for public use at a cost of \$90,000. These funds have not been identified for appropriation at this time. Based on the outcome of the joint use agreements, staff will return to Council for an appropriation.
