SUBJECT: AMENDMENT OF CHAPTER 2.370 TO DESIGNATE CITY REPRESENTATIVES AS ALTERNATE MEMBERS OF THE DISASTER EMERGENCY SERVICES COUNCIL

TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 2, CHAPTER 2.370 TO ADD A NEW SECTION 2.370.035 TO THE PASADENA MUNICIPAL CODE TO DESIGNATE ALTERNATE MEMBERS OF THE DISASTER EMERGENCY SERVICES COUNCIL

PURPOSE OF ORDINANCE:

The purpose of this ordinance is to implement the direction of the City Council to designate certain city representatives as alternate members of the City's Disaster Emergency Services Council in the absence of the Mayor, City Manager, Police Chief or Fire Chief. The City Council directed preparation of this ordinance on December 18, 2006.

REASON WHY THIS LEGISLATION IS NEEDED:

Pursuant to Section 410 of the City Charter, the City Council has authority to modify the organization of city operations by amendment of the Pasadena Municipal Code.

PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED:

This ordinance will affect the members of the City's Disaster Emergency Services Council and staff working with that Council.

FISCAL IMPLICATIONS:

The appointment of alternate members to the Disaster Emergency Services Council has no fiscal impact on the City's General Fund.


POLICY CHANGE:



**AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 2, CHAPTER 2.370 TO ADD A NEW SECTION 2.370.035 TO THE PASADENA MUNICIPAL CODE TO DESIGNATE ALTERNATE MEMBERS OF THE DISASTER EMERGENCY SERVICES COUNCIL**

The People of the City of Pasadena ordain as follows:

**SECTION 1.** Title 2, Chapter 2.370 of the Pasadena Municipal Code is amended to add a new Section 2.370.035 to read:

**“2.370.035 Alternate members.**

In the absence (or inability to act) of the mayor, the city manager, the police chief or the fire chief, the following city representatives are appointed to sit as alternate members of the Disaster Emergency Services Council for their respective departments: the vice mayor, the assistant city manager, the deputy police chief and the fire bureau chief.”

**SECTION 2.** This ordinance shall take effect upon the date of its publication.


