SUBJECT: APPROVAL OF FINAL TRACT MAP NO. 065888, BEING A

CONVERSION OF NINE EXISTING RENTAL UNITS INTO NINE

CONDOMINIUMS, AT 1036-1044 EAST ORANGE GROVE BOULEVARD

RECOMMENDATION

It is recommended that the City Council adopt the following resolution to:

1) Approve Final Tract Map No. 065888; and

2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

BACKGROUND

The subject Final Tract Map, being the conversion of an eight-unit apartment building and one-unit single-family residence into a nine-unit condominium project at 1036-1044 East Orange Grove Boulevard, was reviewed and approved in tentative form by the Hearing Officer on July 13, 2006.

The developer's engineer has completed the final map which has been reviewed by the County. Said map is now ready for the City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City, including monumentation. A building permit has been issued for the development of the site. No additional discretionary actions were required.

All rental units were vacated by August 2006. The apartment building consisted of six two-bedroom units that rented for \$800/month, and two studios that rented for \$600/month. The single-family residence rented for \$2,000/month. Construction on the new carports and building modifications began in March 2007 and is approximately 85 percent completed with the remaining 15 percent tentatively scheduled to be completed in October 2007.

BACKGROUND (Continued)

The project is not subject to the Inclusionary Housing Ordinance in Pasadena Municipal Code Title 17, Chapter 17.42, as it consists of less than ten newly constructed units. The applicant has complied with the Tenant Protection Ordinance – Pasadena Municipal Code (PMC) Chapter 9.75.

FISCAL IMPACT

The developer has paid for all costs to prepare and process the subdivision documents. Approval of this action will generate additional revenue to the City in an amount to be determined later in the form of property taxes.
