Subject: Authorization to Enter into a Contract with Mueller Service California Inc., dba Mueller Service Company for Providing Utilities Maintenance Services for Pasadena Water and Power, Specification WD-07-05.

RECOMMENDATION

It is recommended that the City Council:

1. Accept the bid dated February 28, 2008 submitted by Mueller Service California Inc., dba Mueller Service Company in response to Specification WD-07-05, for Providing Utilities Maintenance Services for Pasadena Water and Power;
2. Reject all other bids; and
3. Authorize the City Manager to issue a contract for a two-year period to Mueller Service California Inc, dba Mueller Service Company, with two optional one-year extensions. The contract shall not exceed \$ 750,000 annually for Items A through F.

BACKGROUND

Specification WD-07-05 provides for a contract to Provide Utilities Maintenance Services to Pasadena Water and Power (PWP). The services will assist PWP crews to meet capital improvement and maintenance goals that include replacing water meters, service laterals, and fire hydrants and exercising all distribution system gate valves every year.

The Notice Inviting Bids for Specification WD-07-05 was published in the Pasadena Journal on February 14, 2008. In response to the Notice Inviting Bids, the Specification was sent to eleven contractors.

A summary of the three bids that were received is in the attached chart.

Bids were evaluated by multiplying each unit bid price by an estimated quantity and then adding the products to arrive at a total bid. The estimated quantities are based on anticipated annual work load by PWP. The total bid price is used for comparing bids only and does not constitute the total value of the contract. Any work to be performed by the contractor shall be a supplement to the work performed by PWP's Water Division field crews to meet capital improvement goals and developer demands.

Mueller Service California Inc., dba Mueller Service Company, is the lowest responsive bidder for Item A through Item F and complies in all respects with the requirements of the Specification. Staff recommends that the Council award a contract to Mueller Service California Inc., dba Mueller Service Company, for a not to exceed amount of \$750,000 annually.






