# TITLE OF PROPOSED ORDINANCE

AN ORDINANCE OF THE CITY OF PASADENA AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF PASADENA ESTABLISHED BY SECTION 17.20.020 OF THE PASADENA MUNICIPAL CODE TO CHANGE THE ZONING DESIGNATION FOR 505 SOUTH WILSON AVENUE

# PURPOSE OF ORDINANCE

This ordinance implements and codifies the zoning map amendment approved by the City Council on March 3, 2008. The purpose of this ordinance is to amend the zoning map to change the existing zoning at 505 South Wilson Avenue from RM-32 (Multi-family Residential District, 32 dwelling units/net acre) to PS (Public and Semi-Public).

## **REASON WHY LEGISLATION IS NEEDED**

This ordinance is needed to allow Caltech to implement its School Master Development Plan. This change is consistent with the General Plan and Zoning Code.

# PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED

The Planning and Development Department will implement the ordinance.

## FISCAL IMPACT

There will not be an immediate fiscal impact as a result of this amendment to the zoning map. Development fees will be collected by the Planning and Development Department from any future development proposed on the site.

**SECTION 1.** This ordinance, due to its length and the corresponding cost of publication will be published by title and summary as permitted by Section 508 of the Pasadena City Charter. The approved summary of this ordinance is as follows:


