SUBJECT: APPROVAL OF FINAL TRACT MAP NO. 063608, BEING A SIX UNIT

CONDOMINIUM PROJECT, AT 41 NORTH OAK AVENUE

RECOMMENDATION:

It is recommended that the City Council:

- Adopt a resolution to approve Final Tract Map No. 063608; 1)
- Authorize the City Clerk to execute the Certificate on the map showing the City 3) Council approval of said map.

BACKGROUND:

The subject Final Tract Map, being a six unit condominium project, at 41 North Oak Avenue, was reviewed and approved in tentative form by the Hearing Officer on October 12, 2006.

The developer's engineer has completed the final map which has been reviewed by the County. Said map is now ready for City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City, including monumentation.

The site was previously developed with a vacant single-family residence that was purchased by developer in December 2004, and relocated in April 2008. The remaining basement and garage were demolished in May 2008. Construction on the condominium project is scheduled to begin in August 2008, and is tentatively scheduled to be completed in June 2010.

BACKGROUND: (Continued)

The project consisting of six condominium units is not subject to standards of the Inclusionary Housing Requirements, Chapter 17.42 of the PMC. The Inclusionary Housing Requirements are applicable to newly constructed residential dwelling units of ten of more, or subdivision maps consisting of ten or more residential lots. Because the project is replacing a single-family residence, the project is not subject to the requirements of the Tenant Protection Ordinance — Pasadena Municipal Code (PMC) Chapter 9.75.

FISCAL IMPACT:

The developer has paid for all costs to prepare and process the subdivision documents. Approval of this action will generate additional revenue to the City in an amount to be determined later in the form of property taxes.
