SUBJECT: APPROVAL OF FINAL TRACT MAP NO. 063227, BEING A 14-UNIT
CONDOMINIUM PROJECT, AT 53-71 SOUTH SAN GABRIEL
BOULEVARD

RECOMMENDATION

It is recommended that the City Council:

- 1) Adopt a resolution to approve Final Tract Map No. 063227; and
- 2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

BACKGROUND

The subject Final Tract Map, being a 14-unit condominium project at 53-71 South San Gabriel Boulevard, was reviewed and approved in tentative form by the Subdivision Committee on September 14, 2005.

The developer's engineer has completed the final map which has been reviewed by the County. Said map is now ready for the City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City, including monumentation. A building permit has been issued for the development of the site. No additional discretionary actions were required.

Construction on the project began in December 2005 and is 85% complete, with the remaining 15% scheduled to be completed in March 2008. The project was constructed on the site of eight single-family residences that were demolished in November 2005.


BACKGROUND (Continued)

The project consisting of 14 condominium units is subject to standards of the Inclusionary Housing Requirements, Chapter 17.42 of the PMC, and has complied by offering affordable units on-site. The project involved the demolition of eight existing single-family residences. As such, the project will not be subject to the Tenant Protection Ordinance – Pasadena Municipal Code (PMC) Chapter 9.75, because single family homes are exempt under the provisions of the Ordinance.

FISCAL IMPACT

The developer has paid for all costs to prepare and process the subdivision documents. Approval of this action will generate additional revenue to the City in an amount to be determined later in the form of property taxes.


