

RESOLUTION NO.

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF PASADENA DECLARING THE RESULTS OF THE
SPECIAL MUNICIPAL ELECTION HELD ON FEBRUARY 5, 2008**

WHEREAS, a Special Municipal Election was called by the City Council to be held on February 5, 2008, in the City of Pasadena, which election was consolidated with the Statewide Presidential Primary Election held at said time. Said election was called to place City Measure D, Pasadena Utility Users Tax Continuation Measure, on the ballot; and

WHEREAS, notice of the election was given in time, form and manner as provided by law, that voting precincts were properly established, that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received, and canvassed, and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California; and

WHEREAS, the Los Angeles County Clerk/Registrar-Recorder has canvassed the returns of the above-referenced election and has certified the results to this City Council, the results are received, attached, and made a part hereof as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena, as follows:

SECTION 1. At the Special Municipal Election held on February 5, 2008, in the City of Pasadena, the whole number of ballots cast in the precincts was 30,886, the whole number of absentee ballots cast was 10,230, making a total of 41,116 ballots cast in said election.

SECTION 2. That the City Council does declare the following to be the results of said Special Municipal Election held in the City of Pasadena:

MEASURE D. PASADENA UTILITY USERS TAX CONTINUATION MEASURE

Shall an ordinance be adopted to ratify and continue Pasadena's existing Utility Users Tax to fund general city services, including essential municipal services such as police, fire, street repair, parks and libraries, provided that low-income seniors and disabled residents remain exempt, the ordinance is updated to treat taxpayers equally regardless of technology used, and independent annual audits of the tax are required?

Yes votes: 21,375 (58.41%) No votes: 15,219 (41.59%)

That as a result of the election, a majority of the voters voting on Measure D did vote in favor of it, and that the Measure was carried, and shall be deemed adopted and ratified.

SECTION 3. That the number of votes given at each precinct for and against Measure D, were as listed in Exhibit A, attached and made a part hereof.


