	Richard Bruckner, Director of Planning and Development Department, provided a context for the General Plan Update

(GPU) process, indicated that Council would be provided with statistical information that had been developed by staff, and responded to questions.

The City Manager summarized the City of Pasadena Citizen Survey information provided in the agenda packet, and responded to questions.

Council broke into discussion groups that focused on the following areas: What about Pasadena are we proud of?; Personal Preamble to the GPU; General Plan (GP) Principles 1, 2, 3 and 4; and GP Principles 5, 6, 7 and any new (proposed) Principles.

Ms. Tripp-Jones reviewed the written worksheet comments developed in the discussion groups activity. She indicated that a report that captures the workshop (as reflected in the discussion groups' worksheets) would be produced for Council, and that this information would reflect Council's sharing of their views and "taking each other's temperature" on these views, as expressed during the workshop. She encouraged Council to meet again in this type of workshop format.

The City Manager suggested that a second Council workshop could focus on a report card for the 1994 General Plan.

The Mayor emphasized that the City and Council are at the beginning of a General Plan Update process that will take up to 18 months.
