SUBJECT: AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING IMPLEMENTATION OF THE SCHEDULED JULY 1, 2009 CONSUMER PRICE INCREASE TO THE STIPENDS OF THE MAYOR AND MEMBERS OF THE CITY COUNCIL SET FORTH IN SECTION 2.05.210 B OF THE PASADENA MUNICIPAL CODE

## TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING IMPLEMENTATION OF THE SCHEDULED JULY 1, 2009 CONSUMER PRICE INCREASE TO THE STIPENDS OF THE MAYOR AND MEMBERS OF THE CITY COUNCIL SET FORTH IN SECTION 2.05.210 B OF THE PASADENA MUNICIPAL CODE.

## PURPOSES OF THE ORDINANCE:

Section 2.05.210 B of the Pasadena Municipal Code provides an automatic July 1 increase in the stipends of the Mayor and Councilmembers by the same percentage as any increase in the consumer price index. This ordinance suspends the operation of this subsection with the effect that the consumer price index increase otherwise required will not take effect commencing July 1, 2009.

## REASONS WHY LEGISLATION IS NEEDED:

An ordinance is appropriate and the necessary means to suspend, or render inoperative, the effect of an existing ordinance for a given time period. The City Council directed preparation of this ordinance at its meeting on June 15, 2009.

The Mayor and members of the City Council will be affected by this ordinance.


**FISCAL IMPACT:**

The Consumer Price Index for urban consumers in the Los Angeles - Anaheim - Riverside area for the twelve month period beginning December 1st and ending November 30th increased approximately 1.3%. This ordinance will result in an overall budget savings of approximately \$1,812 in Fiscal Year 2009 - 2010.

There are no policy changes implicated by the proposed ordinance.

**SECTION 2.** This Ordinance shall not be codified.

**SECTION 3.** This Ordinance shall take effect upon its publication.


