SUBJECT: APPROVAL OF FINAL TRACT MAP NO. 063559, BEING A NINE-UNIT CONDOMINIUM PROJECT, AT 445 SOUTH OAKLAND AVENUE

RECOMMENDATION:

It is recommended that the City Council:

- 1) Adopt a resolution to approve Final Tract Map No. 063559; and
- 2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

BACKGROUND:

The subject Final Tract Map, consisting of nine residential condominium air parcels at 445 South Oakland Avenue, was reviewed and approved in tentative form by the Hearing Officer on August 10, 2006.

The developer's engineer has completed the final map which has been reviewed by Los Angeles County Department of Public Works. Said map is now ready for City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City. Included among these conditional requirements was monumentation. No additional discretionary actions were required.


The site was formerly developed with two single-family residences. The residences were vacant when the developer acquired them in February 2004, and a demolition permit is anticipated for March 2009. Construction on the new condominium project will begin in March 2009 and is scheduled to be complete in September 2010.

The project consisting of nine units is not subject to standards of the Inclusionary Housing Requirements, Chapter 17.42 of the PMC. The Inclusionary Housing Requirements are applicable to newly constructed residential dwelling units of ten or more, or subdivision maps consisting of ten or more residential lots. The project is not subject to the requirements of the Tenant Protection Ordinance – Pasadena Municipal Code (PMC) Chapter 9.75, as single-family residences do not apply to the ordinance.

FISCAL IMPACT:

The developer has paid for all costs to prepare and process the subdivision documents. Approval of this action will generate additional revenue to the City in an amount to be determined later in the form of property taxes.


