FISCAL YEAR 2010 OPERATING BUDGET AND GENERAL FEE SCHEDULE AMENDMENTS AND APPROVAL OF PURCHASE ORDER TO PURCHASE SELF-CONTAINED BREATHING APPARATUS FROM L. N. CURTIS & SONS Recommendation of City Manager:

(1) Authorize a journal voucher implementing certain amendments to the fiscal year 2010 Operating Budget, as detailed in the background section of the agenda report;

(2) Amend the General Fee Schedule for State and County mandated increases to parking fines and change the description of Paramedic billing fee from "Mileage Advanced Life Support per mile" to "Mileage per mile"; and

Recommendation of City Manager: Adopt a resolution supporting wilderness and wild river designations for the San Gabriel Mountains. (Resolution No. 8999)

Recommendation of Recreation and Parks Commission: At their regular meeting on September 15, 2009, the Recreation and Parks Commission voted to recommend the City Council adopt a resolution supporting congressional designation of additional wilderness areas in the San Gabriel Mountains.

The Mayor, Chair of the Legislative Policy Committee, summarized the agenda report.

Martin Pastucha, Director of Public Works Department, clarified the uses of wilderness areas.

BUDGET UPDATE

Recommendation of City Manager: This report is for information only, no City Council action is requested at this time.

The City Manager reviewed the agenda report on the Fiscal Year (FY) 2010 Budget as part of a PowerPoint presentation, and responded to questions.

Vice Mayor Gordo was excused at 7:38 p.m.

Discussion followed on the various personnel cost reduction alternatives and ongoing budget balancing strategy.

Richard McDonald, Pasadena resident, suggested the Council and City Manager look at what the City can do to grow, when discussing budget issues and strategies (e.g., new local programs and ways to grow the economy).

Following discussion, the City Manager indicated that he would continue to move forward with the financial strategies and the preferred option (2% lump sum salary increase in lieu of 4% increase to base salary) to reduce personnel costs, as set out in the agenda report, with a budget update to be provided to Council prior to the holiday recess; and would return to Council if it was necessary to obtain approval for any change in the memorandum of understanding for any bargaining unit.

On order of the Mayor, the report was received and filed.

PUBLIC HEARING

PUBLIC HEARING: ADOPTION OF CERTAIN NEW FEDERAL STANDARDS RELATING TO ELECTRIC UTILITIES UNDER THE PUBLIC UTILITIES REGULATORY POLICIES ACT AND THE ENERGY INDEPENDENCE AND SECURITY ACT OF 2007 FOR WATER AND POWER DEPARTMENT

Recommendation of City Manager: It is recommended that the City Council, following a public hearing:

- (1) Finds that the action taken herein is exempt from the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines Sections 15061(b)(3) (general rule) and 15308 (actions by regulatory agencies for the protection of the environment);
- (2) Determines that the Water and Power Department (PWP) policies, rates and practices that have been initiated and/or are under development are consistent in meeting and adopting three of the four new federal standards amended by the Energy Independence and Security Act of 2007 amendments to the Public Utility Regulatory Polices Act of 1978;
- (3) Determines not to adopt certain aspects of the Smart Grid Information Standard (Standard 4) because PWP does not currently offer real-time retail electricity rates or possess the capability of implementing such rates, and directs staff to evaluate the cost-effectiveness and capability of establishing such rates as part of PWP's electric rate and cost of service study and any future smart grid implementation efforts; and
- (4) Adopt a resolution to Determine Certain New Federal Standards for Electric Utilities Under the Public Utilities Regulatory Policies Act of 1978, as Amended by the Energy Independence and Security Act of 2007. (Resolution No. 9000)

The Mayor opened the public hearing.

The City Clerk reported the notice of public hearing was published on November 9, 2009 in the <u>Pasadena Star-News</u>; and no correspondence was received.

Phyllis Currie, General Manager of Water and Power Department, introduced the agenda item, discussed the Department's strategy to implement a Smart Grid Information system and real-time energy rates in the future, and responded to questions.

Fred Lyn, Legislative and Regulatory Affairs Manager, reviewed the agenda report as part of a PowerPoint presentation and responded to questions.

The City Manager noted that the City will be able to gather valuable information from other agency/City experiences in implementing Smart Grid systems, which can then be used to effectively implement the City's strategies in this area.

It was moved by Councilmember Haderlein, seconded by Councilmember McAustin, to close the public hearing. (Motion unanimously carried) (Absent: Vice Mayor Gordo)

It was moved by Councilmember Haderlein, seconded by Councilmember McAustin, to approve the City Manager's recommendation. (Motion unanimously carried) (Absent: Vice Mayor Gordo)

COUNCIL COMMENTS

Councilmember Robinson requested that an item be placed on a future agenda that would allow consideration of a motion to renew the motion to approve the City Manager's recommendation pertaining to the Call for Review of a decision by the Design Commission regarding the cornice material on the Raymond Renaissance Project, since she was not present at the Council meeting of November 2, 2009, and unable to participate in the discussion and deliberations on this important matter.

Councilmember Holden commented and distributed information on the Community Oriented Policing Services Program (COPS) that he had recently obtained at the National League of Cities Conference (the program that is now led by the City's former Chief of Police Bernard Melekian).
