This Permanent Open-Space Easement is reserved in accordance with the following:

- 1. The Property shall be used for open-space, park, and recreational purposes.
- 2. This Permanent Open-Space Easement shall be perpetual in duration.
- 3. This Permanent Open-Space Easement is and shall be binding upon any and all successive owners of the Property.
- 4. The purpose of this Permanent Open-Space Easement is to retain the Property for use solely for open-space, park and recreational purposes.
- 5. The reservation of this Permanent Open-Space Easement is made subject to all existing leases between Metropolitan and current lessees respecting current uses of the Property including specifically existing equestrian trails that traverse the Property which may be relocated to compliment other uses.
