SUBJECT:

**AUTHORIZATION TO ENTER INTO PURCHASE ORDER** 

CONTRACTS WITH DELL MARKETING L.P. FOR THE PURCHASE OF 114 DESKTOP COMPUTERS; AND WITH PIPS TECHNOLOGY FOR THE PURCHASE OF 4 AUTOMATED LICENSE PLATE READERS (ALPR) AND A CAMERA UPGRADE TO THE EXISTING ALPR

#### **RECOMMENDATION:**

It is recommended that the City Council authorize:

- The issuance of a purchase order contract to Dell Marketing L.P. in an amount not to exceed \$120,990 for the purchase of 114 new desktop computers; Competitive bidding is not required pursuant to City Charter section 1002(H), contracts with other governmental entities or their contractors for labor, material, supplies or services under Western States Contracting Alliance (WSCA) B27160;
- 2) The issuance of a purchase order contract to PIPS Technology, a Federal Signal Company, in an amount not to exceed \$122,797 for the purchase of four automated license plate readers (ALPR) and a camera upgrade for one existing ALPR; The proposed purchase is exempt from competitive bidding, pursuant to City Charter section 1002 (H) contracts with other governmental entities or their contractors for labor, material, supplies or services.
- 3) Grant the proposed contracts an exemption from the competitive selection process of the Competitive Bidding and Purchasing Ordinance pursuant to Pasadena Municipal Code Section 4.08.049 (B), contracts for which the City's best interest are served.

### **BACKGROUND:**

The Police Department was awarded a \$1,187,382 COPS Technology Grant in 2001. The grant was provided to implement new CAD/RMS/Mobile Data/Field Based Reporting and Crime Analysis systems. On January 25, 2011 a grant modification from

the COPS Office was approved to allow the Department to replace aging computers, upgrade an existing mobile automated license plate reader (ALPR), and outfit four additional vehicles with ALPR equipment.

There are 144 desktop PC's in the Police Department that are over six years old. Replacement of 114 desktop computers will reduce the number of outdated computers which will improve the efficiency for end users and relieve Technical Services support personnel of responding to service calls.

Mobile Automated License Plate Reader (ALPR) systems consist of four cameras affixed to a patrol vehicle, software to manage the information, and network connectivity to upload the information to police domain servers. Cameras read the license plates of vehicles both driving on the road and parked. The system checks each plate against the stolen vehicle database and then stores a photo with date, time, and location data for retrieval during criminal investigations. The single existing ALPR system has proven beneficial for locating suspects. However, it cannot be widely deployed and is occasionally out of service. The existing ALPR system will be upgraded, and with five ALPR equipped vehicles, every service area will have an ALPR operating on a regular basis.

PIPS was the vendor selected by the Los Angeles County Urban Area Security Initiative (UASI) granting authority as the ALPR system approved for purchases utilizing UASI grant funds. Because all County law enforcement agencies are using the same system, they can readily share data for improved operational effectiveness region-wide.

#### **COUNCIL POLICY CONSIDERATION:**

Approving this request meets the City of Pasadena Strategic Plan goals of maintaining fiscal responsibility and ensuring public safety.
