SUBJECT: AN UNCODIFIED ORDINANCE OF THE CITY OF PASADENA SUSPENDING IMPLEMENTATION OF THE SCHEDULED JULY 1, 2011, CONSUMER PRICE INCREASE TO THE STIPENDS OF THE MAYOR AND MEMBERS OF THE CITY COUNCIL SET FORTH IN SECTION 2.05.210 (B) OF THE PASADENA MUNICIPAL CODE

## **TITLE OF PROPOSED ORDINANCE:**

AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING IMPLEMENTATION OF THE SCHEDULED JULY 1, 2011, CONSUMER PRICE INCREASE TO THE STIPENDS OF THE MAYOR AND MEMBERS OF THE CITY COUNCIL SET FORTH IN SECTION 2.05.210(B) OF THE PASADENA MUNICIPAL CODE.

## **PURPOSES OF THE ORDINANCE:**

Section 2.05.210 (B) of the Pasadena Municipal Code provides an automatic July 1 increase in the stipends of the Mayor and Councilmembers by the same percentage as any increase in the consumer price index. This ordinance suspends the operation of this subsection with the effect that the consumer price index increase otherwise required will not take effect commencing July 1, 2011.

## **REASONS WHY LEGISLATION IS NEEDED:**

An ordinance is appropriate and the necessary means to suspend, or render inoperative, the effect of an existing ordinance for a given time period. The City Council directed preparation of this ordinance at its meeting of June 13, 2011.





**SECTION 2.** This Ordinance shall not be codified.
