CEREMONIAL MATTERS

PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

Councilmember Madison recognized and congratulated two student artists, Ketsi Sanchez and Rodrigo Soto, along with Rudy Ramirez, Principal of San Rafael Elementary School.

Michelle White, Affordable Housing Services, requested that the General Plan be presented to the Northwest Commission and other interested commissions in addition to the Planning Commission.

John Seeley, Pasadena resident, asked the City to develop an anti-foreclosure policy.

Michelle Richardson-Bailey, Northwest Commission Chair, requested that the City Council direct the Design Commission to adopt a final design for the Heritage Square Project consistent with the original Craftsman design that was shared with the Northwest Commission and the community.

Lydia Breen, Altadena resident, asked Council to intervene in the eviction of Deidra Duncan and requested that the City Council place a moratorium on evictions for foreclosed homes.

Deidra Duncan, Pasadena resident, spoke regarding her eviction, and asked for help from the City Council and submitted a letter. The Mayor indicated that staff will review the matter and contact her attorney, Philip Koebel.

AMENDMENT TO ARTICLE 3 (CIVIC **PUBLIC HEARING: EVENTS** AND FACILITIES) OF THE **PASADENA** MUNICIPAL CODE REGARDING THE NUMBER OF LARGE EVENTS HELD ANNUALLY AT THE ROSE BOWL STADIUM Recommendation:

Adopt a resolution certifying the Final Environmental Impact Report, Adopting Findings Pursuant to the California Environmental Quality Act (CEQA), and Adopting a Mitigation Monitoring and Reporting Program for the Amendment to Pasadena Municipal Code, Title 3 (Civic Events and Facilities) also known as The Arroyo Seco Public Lands Ordinance and the Temporary Use of the Rose Bowl Stadium by the National Football League (NFL);

(2) Adopt a Resolution Setting Forth the Statement of Overriding Considerations:

(3) Conduct first reading of an ordinance of the City of Pasadena amending Pasadena Municipal Code, Title 3 (Civic Events and Facilities) to increase the number of displacement events in the Rose Bowl area; and

(4) Direct the City Clerk to file a Notice of Determination with the Los Angeles County Recorder. (Resolution Nos. 9250 and 9251)

Recommendation of the Rose Bowl Operating Company: As required by the Operating Agreement between the City and the Rose Bowl Operating Company (RBOC), on November 3, 2012 the RBOC Board of Directors reviewed the proposed amendment to Title 3 and voted to recommend approval of the same by the City Council.

The Mayor opened the public hearing.

The City Clerk reported the notice of public hearing was published on November 8, 2012 in the Pasadena Journal; 805 copies of the notice were mailed. The City Clerk's Office received 13 letters in support; 33 letters in opposition, including a petition in opposition filed with a total of 123 electronic signatures of which 82 were from signers registered as Pasadena residents; and 8 letters stating general concerns.

Councilmember Gordo, Rose Bowl Operating Company Chair, introduced the agenda item.

Michael Beck, City Manager, and Darryl Dunn, General Manager for the Rose Bowl, summarized the agenda report, and responded to questions.

Vince Bertoni, Director of the Planning Department, provided an overview of the Environmental Impact Report (EIR) and David Reyes, Principal Planner, summarized the agenda report as part of a PowerPoint presentation. Both responded to questions.

John Mudridge, Fehr and Peers representative, summarized the traffic and transportation section of the EIR as part of a PowerPoint presentation, and responded to questions.

Daniel S. Barrett, Barrett Sports Group, LLC Principal, summarized the Interim NFL Lease Analysis as part of a PowerPoint presentation, and responded to questions.

Brian Biery, Pasadena resident, expressed concerns regarding the Rose Bowl EIR.

Councilmember Tornek stated his concerns and opposition regarding the negative impacts that would result from having an NFL team play in the Rose Bowl, with the most harm coming to the surrounding recreational area and neighborhoods. He cited his lack of confidence in what he considers the speculative nature of the analysis and calculations presented in the Statement of Overriding Considerations (SOC), which anticipates enough net revenues to be generated from an NFL team to offset the budget shortfall created by the Rose Bowl Renovation Project.

Councilmember Masuda asked staff to evaluate what further mitigation measures might be considered to address the "significant and unavoidable impacts" referred to in the proposed Statement of Overriding Considerations in order to protect neighborhoods from trash, noise, and other issues caused by NFL game day operations.

In response, David Reyes, Principal Planner, provided an overview of additional mitigation measures proposed as part of the RBOC's responsibilities related to NFL events. Lieutenant Bruce George, Pasadena Police Department, addressed the public safety aspects of the mitigation and suggested that there is a need to increase police patrols around the Rose Bowl and in the neighborhoods during game day operations.

Councilmember Madison expressed his concerns with the photographs shown by the public speakers displaying public intoxication at tailgate events, requested further information on the activities of the Police Department on game day, and asked staff to provide an update on the implementation of the measures approved by the City Council in light of past incidents occurring at large Rose Bowl events, specifically those adopted for USC/UCLA football games.

Councilmember Robinson stated her preference for having the Public Safety Committee consider the proposed recommendations and suggestions from speakers such as the

Day One Organization regarding tailgating issues, with the idea that the Committee could review and provide recommendations to the City Council.

Vice Mayor McAustin spoke on the impacts to local entities in the Rose Bowl area, including the Flea Market, the Aquatic Center, Kids Space, and the Golf Course, and stated the need for staff to further consider how to mitigate and make whole those operations that would be negatively affected by an NFL team playing in the Rose Bowl. She also raised the possibility of limiting smaller events in the Rose Bowl area in order to further offset NFL game day impacts to the community, local entities, and neighborhoods. The Vice Mayor stated her preference that the displacement event language in the ordinance be tightened with regard to additional events in the Rose Bowl and that such additions should only pertain to additional NFL events.

In response to questions regarding particulate measurements caused by traffic, Eric Bell, Impact Sciences representative, summarized the CEQA requirements and discussed the health risk measurements, thresholds, and requirements.

David Sams, Brookside Golf Course Manager, provided an overview of the impacts to the Golf Course's operations caused by parking cars on the course for larger events at the Rose Bowl.

Councilmember Gordo stated his support for the City Council to proceed with the certification of the EIR and the amendment to the proposed ordinance, with the understanding that such an approval does not predetermine a deal involving an NFL team, but rather positions the City to participate in negotiations and to analyze the specifics of a deal in the event that an opportunity arises.

Vice Mayor McAustin, following a statement of support for the proposed actions, requested that staff continue to work on mitigating the impacts experienced by the neighborhoods around the Rose Bowl and meeting the existing responsibilities of the City in terms of clean up, monitoring participant behavior, and enforcement for football games in the Arroyo area.

Councilmember Madison, following statements of support for the proposed action, requested that staff provide an update to the City Council on the status of the Central Arroyo Conservancy effort, and also suggested that the Rose Bowl Operating Company, Rose Bowl General Manager, and the City Manager scrutinize the Rose Bowl Renovation Project budget shortfall and conduct an independent review in order to better understand how such a shortfall occurred.

The City Manager confirmed that the first phase of a review will be presented to the City Council prior to the presentation of the proposed funding solution to address the budget gap for the project.

Mayor Bogaard, following statements of support for the proposed action, requested that the proposed ordinance be amended to allow up to 13 additional events exclusively for use by the NFL, and to not allow the replacement of unused event opportunities with other non-NFL events (e.g. concerts, soccer matches, etc.).

It was moved by Councilmember Gordo, seconded by Vice Mayor McAustin, to close the public hearing. (Motion unanimously carried) (Absent: None)

It was moved by Councilmember Gordo, seconded by Vice Mayor McAustin, to approve Recommendations No. 1, 2, and 4, amended as follows:

At that meeting, the RBOC Board of Directors recommended approval of the Ordinance by the City Council."

COUNCIL COMMENTS

The Mayor and City Council congratulated Councilmember Chris Holden on his successful election as State Assemblymember, expressed appreciation for his many years of dedicated service, and wished him well in his newly elected position.

Councilmember Chris Holden thanked the Mayor and Councilmembers and commended the Council on their contributions to the City. He also thanked all the Field Representatives, Joyce Streator, Gayle Pullen and Jackie McIntyre who have worked with him through his years of service.

The Mayor gave a brief overview on the procedures for filling the District 3 vacancy, and noted a full discussion on the process is scheduled for the December 3, 2012 City Council meeting.

The City Clerk announced that the nomination period opened for City Council Districts 3, 5, and 7, and the newly formed PUSD Board of Education Districts 1, 3, 5, and 7 on November 13, 2012 and remain open until December 7, 2012.

Councilmember Robinson reported on information received for the One Billion Rising Advocacy Campaign to stop violence against women, requesting the City of Pasadena join in support with other cities. She asked that the Commission on the Status of Women review the campaign and make a recommendation to City Council or Legislative Policy Committee.
