PUBLIC HEARING: ADOPTION OF THE 2013 ANNUAL CITY OF PASADENA SELF CERTIFICATION REPORT IN CONFORMANCE WITH THE CONGESTION MANAGEMENT PROGRAM (CMP) FOR LOS ANGELES COUNTY AND THE 2013 LOCAL DEVELOPMENT REPORT IN ACCORDANCE WITH GOVERNMENT CODE SECTION 65089 Recommendation:

ADOPTION OF THE BICYCLE TRANSPORTATION PLAN

Recommendation: It is recommended that the City Council cancel the public hearing to be rescheduled for consideration at a later date.

The Mayor reported that the above item had been heard by the Municipal Services Committee (MSC) on July 9, 2013, and the recommendation to cancel the public hearing was an outcome from that discussion.

Councilmember McAustin, Chair of the Municipal Services Committee, briefly summarized the discussion and direction given to staff, and noted that the Committee is looking forward to seeing the Bicycle Transportation Plan again in the coming weeks.

Jonathan Edewards, Pasadena Complete Street Coalition and DPNA, spoke in support of staff's recommendation to cancel the public hearing, thanked the Committee for their recommended action, and stated that the Pasadena Complete Street Coalition will be preparing a letter in the near future listing a variety of new recommendations for the Plan.

AUTHORIZATION TO AMEND CONTRACT NO. 20,023 WITH OPOWER, INC., AND THE SOUTHERN CALIFORNIA PUBLIC POWER AUTHORITY FOR AN ADDITIONAL AMOUNT OF \$309,000 FOR SERVICES TO PROVIDE HOME ENERGY USE REPORTS THROUGH JUNE 30, 2014 Recommendation:

Find that the proposed action is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines 15061(b)(3), general rule; Section Find that the proposed contract is exempt from the (2) competitive bidding process pursuant to City Charter Section 1002(F), contracts for professional or unique services; and Authorize the City Manager to amend Contract No. (3)20,023 with OPower (formerly Positive Energy, Inc.,) to provide home energy use reports and related services for one additional year through June 30, 2014 for an additional amount of \$309,000, or total amount not to exceed \$927,000. Richard Luczyski, Pasadena resident, expressed concerns regarding the sharing of customer data with an outside firm.

Mustang Sally Ramirez, Los Angeles resident, asked that military veterans, pilots and U.S. citizens be hired for this contract.
