### **CEREMONIAL MATTERS**

Councilmember McAustin arrived at 6:10 p.m.

Vice Mayor Robinson, briefly spoke about the newly reconstituted, "Volunteers in Pasadena" or "VIP" program and introduced those volunteers who were present, and thanked everyone who attended and assisted with the event at Brookside Park this past weekend.

Mayor Bogaard recognized Vice Mayor Robinson for her significant contribution in strengthening and re-energizing Pasadena's traditions and fundamental values. Michele Harris, VIP volunteer, also expressed her appreciation to the Vice Mayor for starting the "VIP" program, providing the volunteers with the opportunity to give back to individuals in need and to the community as a whole.

The Senior Assistant City Clerk administered the oath of office to Warren Sata as Accessibility & Disability Commissioner.

Genevieve Clavreul, Pasadena resident, expressed disappointment regarding the City's response to her ongoing issue with the overgrown trees near her home at Locust Avenue and Hudson Street. She also asked that the City Council address the issue of frequent cancellations of Senior Commission meetings.

Mustang Sally Ramirez, Los Angeles resident, expressed concerns regarding gang violence in Pasadena and spoke of an incident she had encountered on July 16, 2013 near Lake Avenue and Colorado Boulevard.

Floyd Folven, Pasadena resident, expressed concerns regarding the 2012-2013 Civil Grand Jury Report and it's reporting on Pasadena, and submitted a copy of the report.

Emanuel Najera, Pasadena resident, cited the on-going issues with the City of Detroit, and raised questions regarding how Pasadena will address its future financial plan.

In response to the public speaker comments regarding Pasadena's finances, the Mayor briefly discussed the Finance Committees duties pertaining to the City's five year plan.

The City Manager encouraged Mr. Najera to attend the next Finance Committee meeting and indicated he would provide Mr. Najera with a copy of the City's five year financial report.

## **COUNCIL COMMENTS**

Councilmember Gordo expressed concerns regarding the discontinued parking passes for frequent visitors in neighborhoods and asked that this issue be addressed through the Economic Development and Technology Committee.

Councilmember Masuda spoke on parking issues around Pasadena City College stating students are parking in the neighborhoods, questioned what the City can do to help resolve this ongoing issue, and urged PCC to implement enforcing the students to park in PCC lots or offer free parking to the students.

Councilmember Madison asked staff to provide an update on the Enterprise Zones program either at a City Council or Legislative Policy Committee meeting.

The City Manager stated information on the Enterprise Zone program will be provided in the City Manager's Newsletter and if more information is needed it will be agendized.

Councilmember Madison discussed briefly his attendance at a press conference Los Angeles County Metropolitan Transportation Authority this past Saturday regarding the proposed SR710 Tunnel project, and indicated that efforts are underway with staff to determine a date to agendize the issue.

Councilmember Kennedy commended Mercy Santoro, Director of Human Services, Horace Wormely, Neighborhood Service Administrator and City staff for organizing the 4th Annual Robinson Park Summer Festival that took place on Saturday, July 20, 2013.

Councilmember Kennedy asked the City Council to consider agendizing a discussion regarding the plight of African American males in Pasadena, and invite Dr. Ross from the California Endowment to speak on the activities and programs that the Endowment offers throughout Los Angeles County.

(1) Find that the adoption of the revised Enforcement Program and the Renewable Portfolio Standard (RPS) Procurement Plan, pursuant to Section 399.30 of the Public Utilities Code (PUC), is exempt from the California Environmental Quality Act (CEQA) per Section 15061(b)(3); (2) After a public hearing, adopt the proposed revised Enforcement Program for PWP pursuant to Section 399.30(e) of the PUC; and

Adopt the proposed RPS Procurement Plan for PWP (3)pursuant to Section 399.30(f) of the PUC. Recommendation of Municipal Services Committee: On 2013. Municipal Services Committee Julv 9. the recommended that the City Council adopt the proposed revised Enforcement Program and Procurement Plan. Recommendation of Environmental Advisory **Committee:** On June 18, 2013, the Environmental Advisory Committee recommended that the City Council adopt the proposed revised Enforcement Program and Procurement Plan.

The Senior Assistant City Clerk reported the notice of public hearing was published on July 11, 2013 in the <u>Pasadena</u> <u>Journal</u>; and no correspondence was received.

Councilmember McAustin, Chair of Municipal Services Committee, noted the above item had been heard and unanimously approved by the Municipal Services Committee.

Phyllis Currie, General Manager of Water and Power Department, introduced the item, and Gurcharan Bawa, Assistant General Manager, reviewed the agenda report as part of a PowerPoint presentation.

Floyd Folven, Pasadena resident, expressed concerns regarding related State policies and requirements, and voiced opposition to increasing water and power's rates.

Mustang Sally Ramirez, Los Angeles resident, expressed her concerns regarding undocumented workers, asked that military veterans and pilots be hired for City contracts, and suggested lowering water and power bills for those who have served in the military.

It was moved by Councilmember McAustin, seconded by Vice Mayor Robinson, to close the public hearing. (<u>Motion</u> <u>unanimously carried</u>) (Absent: Councilmember Gordo)
