CEREMONIAL MATTERS

Lieutenant John Dewar, introduced Sergeant Mario Ortiz as the new Sergeant-at-Arms, and provided information on his background and achievements.

The City Clerk announced new and enhanced assistive listening devices and signage for the Council Chamber, noting the changes will increase accessibility to public meetings and promote awareness of available accommodations for those individuals in the community with hearing loss issues.

PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

John Orr, Pasadena resident, spoke on behalf of the Hearing Loss Association of Los Angeles and the Accessibility and Disability Commission, and commended the City Council, City Clerk, and staff for enhancing the assistive listening system in the Council Chamber and at the Jackie Robinson Center, and indicated that the hearing loss community is grateful to have increased accessibility to public meetings where quality of life decisions are made that impact residents.

Marvin Schachter, Pasadena resident, spoke on behalf of AARP/P.A.H.G., and urged the City Council to ask Governor Brown to sign AB 1229, to protect and preserve local inclusionary housing programs. He also stated his gratitude to the City Council for upgrading the assistive listening system.

The Mayor indicated that a letter expressing support for the Governor to sign AB 1229 has already been submitted on behalf of the City Council.

Andrew Oliver, First AME Church, stated concerns regarding the plight of young African American men, and invited the community to the "Day of Dialogue" event on September 14, 2013, which will provide an opportunity for the community to come together and have an open discussion regarding serious issues that are affecting the community.

Mustang-Sally Ramirez, Los Angeles resident, expressed her disappointment regarding her recent experience at a prior City Council meeting and spoke in advocacy of military veterans.

POWER PURCHASE AGREEMENT WITH KINGBIRD **PURCHASE** SOLAR, LLC FOR THE **MEGAWATTS OF SOLAR ENERGY** Recommendation:

MUNICIPAL SERVICES COMMITTEE

(1) Find that the recommended contract authorization is exempt from the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines Section 15061(b)(3), general rule;

OF

- (2) Authorize The City Manager to enter into a Power Purchase Agreement with Kingbird Solar, LLC, to purchase 100% of the renewable energy and capacity from the proposed Kingbird Solar photovoltaic project (Kingbird Solar Project), to be located in the Antelope Valley of Kern County, California, for a total of 20 MW;
- (3) Find that the contract is exempt from the City of Pasadena's (City) competitive bidding rules, pursuant to City Charter Section 1002(F), contracts for professional or unique services; and
- (4) Find that the contract is exempt from competitive selection, pursuant to Pasadena Municipal Code Section 4.08.049.

Recommendation of Municipal Services Committee: On August 27, 2013, the Municipal Services Committee recommended that the City Council enter into the 20 MW Power Purchase Agreement with Kingbird Solar, LLC (Agreement No. 21,537)

Councilmember McAustin, Chair of the Municipal Services Committee, introduced the item.

Phyllis Currie, General Manager of Water and Power Department and Gurcharan Bawa, Assistant General Manager, reviewed the agenda report as part of a PowerPoint presentation, and responded to questions.

Councilmember Gordo stated concerns regarding the City's ability to comply with Senate Bill X 1-2, the State's mandated Renewable Portfolio Standard (RPS) goal of 33% by the year 2020, the impact to the City, and requested additional information regarding the measures being taken by staff to ensure the City's compliance.

Ms. Currie pointed out that the City staff is working with all levels of government to ensure that the City continues on a reasonable pace to achieve the State's mandated RPS goal of 33%, and stated that the City is on track with the milestones that have been interpreted at the State level, and mentioned that she will provide the City Council with a chart that will reflect the City's current and future status in terms of milestones to be met.

Following discussion, it was moved by Councilmember McAustin, seconded by Councilmember Tornek, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

PUBLIC HEARING: REPORT ON WATER QUALITY REPORT RELATIVE TO PUBLIC HEALTH GOALS Recommendation:

(1) Find that the proposed actions related to the City of Pasadena's Report on Water Quality Relative to Public Health Goals (PHG) is not subject to the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Sections 15060(c)(2), 15060(c)(3), and 15378, as the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment;

(2) Hold a public hearing on September 9, 2013 for the purposes of accepting and responding to public comments on the PHG; and

(3) Accept the PHG Report.

Recommendation of Environmental Advisory Commission: On August 20, 2013, the PHG Report was presented to the Environmental Advisory Commission as an information item.

Recommendation of the Municipal Services Committee: On July 23, 2013, the PHG Report was

presented to the Municipal Services Committee (MSC) as an information item. The PHG Report was subsequently reviewed by the Pasadena Public Health Department at the request of the MSC.

The Mayor opened the public hearing.

The City Clerk reported that the notice of public hearing was published on August 22, 2013, in the Pasadena Journal, and no correspondence was received.

Phyllis Currie, General Manager of Water and Power Department, and Dr. David Kimbrough, Water Quality Manager, introduced the item, reviewed the agenda report as part of a PowerPoint presentation, and responded to questions.

No one appeared for public comment.

Councilmember Kennedy noted that a professor at California Institute of Technology (CALTECH) designed new technology that removes contaminants from water, and recommended that the appropriate City staff conduct tests of their technology to determine if it is more successful in removing contaminants from the local ground water. He also suggested that staff meet with a prominent local attorney who was directly involved in the Pacific Gas & Electric (PG&E) Chromium litigation to gain additional knowledge on this issue.

Following discussion, it was moved by Councilmember Madison, seconded by Vice Mayor Robinson, to close the public hearing. (Motion unanimously carried) (Absent: None)

It was moved by Councilmember Madison, seconded by Councilmember Gordo, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

RECOMMENDATIONS FROM OFFICERS AND DEPARTMENTS

APPROVAL TO INSTALL A MEMORIAL IN REMEMBRANCE OF THE ARMENIAN GENOCIDE AT MEMORIAL PARK (To be heard at 7:15 p.m. or thereafter) Recommendation:

- (1) Find the proposed project to be exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15304, minor alterations to land; and
- (2) Approve the request to install a memorial in remembrance of the Armenian Genocide at Memorial Park.

Recommendation of the Recreation and Parks Commission: On July 16, 2013, the Recreation and Parks Pasadena Commission considered the Genocide Memorial Committee's (PASAGMC) proposal to install a memorial in remembrance of the Armenian Genocide at Memorial Park. The Commission unanimously supported the Armenian Genocide memorial design and proposal scope, and recommended the City approve the memorial with the location to be determined by the City Council. Although not part of the formal motion, some Commissioners expressed interest in having the City Council consider alternate locations for the placement of the memorial, including a location not in a park, in a park other than Memorial Park, near City Hall, or on property owned by an Armenian organization.

Siobhan Foster, Director of Public Works, and Loren Pluth, Project Manager, introduced the item, reviewed the agenda report as part of a PowerPoint presentation, and responded to questions.

Councilmember Tornek stated his concerns regarding the basis of staff's determination to install the Armenian Genocide Memorial at Memorial Park as opposed to any other City owned property or park.

The City Clerk reported that a PowerPoint presentation, and 12 letters, and a petition with a total of 1,018 signatures, and a document signed by 93 individuals were received in support of, and 4 letters in opposition to, and/or expressing concerns with, the memorial of the Armenian Genocide at Memorial Park.

Vice Mayor Robinson raised concerns regarding future requests for memorials to be placed at Memorial Park, requested information from staff on the City's plans to respond to these proposals, and requested a more substantive explanation from staff as to why other locations were removed from consideration. She also stated concerns regarding the upcoming 100th year anniversary of the Armenian Genocide, and whether or not Memorial Park and its design will be able to accommodate the large number of individuals expected to attend this event.

Loren Pluth provided information on some of the criteria used in the selection of Memorial Park, and noted that the existing master plan indicates hosting memorials as one of the purposes of Memorial Park.

Councilmember McAustin asked staff to further clarify the City's process/procedures on crowd and event management at major events at parks, in anticipation of a possible large gathering of individuals at the 100th year anniversary of the Armenian Genocide at Memorial Park.

Councilmember Tornek expressed his concerns regarding the existing process/policy regarding monuments in parks, and stated that the policy needs to be reviewed and revised in order to adequately respond to future requests, noting that a revised policy should provide better guidance to staff and a greater awareness to the public.

Mayor Bogaard agreed with Councilmember Tornek's point of view regarding the existing policy, and supported the idea of staff studying the policy in anticipation of future proposals.

Members of the City Council expressed gratitude to the Armenian Genocide Memorial Committee for their work, thanked the community for their comments, and congratulated the artist for a beautiful, educational, and powerful piece of art.
