#### **CEREMONIAL MATTERS**

PRESENTATION BY MARK DIERKING, LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY (METRO), PROVIDING AN UPDATE ON THE ACCELERATED REGIONAL TRANSPORTATION IMPROVEMENTS (ARTI) PROJECT – PASADENA SOUNDWALLS

Mark Dierking and Chris Margaronis, spoke on behalf of Metropolitan Transportation Authority (METRO), provided an update regarding the Accelerated Regional Transportation Improvements (ARTI) Project, and responded to questions.

Councilmember Kennedy requested further information on how many of the 9,000 jobs generated by the project will be permanent versus temporary positions, and what type of jobs will be needed.

Members of the City Council expressed concerns regarding the lack of information presented and requested that a clearer, more comprehensive report on the proposed project be provided to the Finance Committee, including the planned locations for the sound walls.

By consensus and on order of the Mayor, the information was received and filed.

Joan Chin, Pasadena resident, spoke in support of the original selection process and the staff recommendation from the September 16, 2013 meeting.

Councilmember Gordo and Madison stated concerns about a revised selection process, and opposed the reallocation of points in the category of experience, noting that a change in the weight and scoring at this time in the process is inappropriate and potentially unfair to responders participating in the process.

Councilmembers Kennedy and Tornek highlighted some of the concerns stated regarding the original selection process and the recommended action from the September 16, 2013 meeting for the Robinson Park Recreation Center Renovation project, and spoke in support of City staff's revised selection process for Professional Design Services.

#### **INFORMTION ITEMS**

### REBRANDING OF PASADENA AREA RAPID TRANSIT SYSTEM (ARTS)

**Recommendation:** This report on the rebranding of the *Pasadena Area Rapid Transit System (ARTS)* as *Pasadena Transit* is provided for the City Council's information.

Fred Dock, Director of Transportation, introduced the item and reviewed the agenda report as part of a PowerPoint presentation.

Yun Ju (Julie) Yeow, Student Art Designer, spoke briefly on the concepts behind the rebranding effort for the Pasadena ARTS Buses, and provided information on the goals for a more clear and efficient branding campaign for Pasadena's public transit system.

Councilmember McAustin thanked everyone involved in the process for their hard work and for a job well done.

Councilmember Madison raised concerns regarding the approval process for the Pasadena ARTS rebranding project, suggesting that the Municipal Services Committee did not have the necessary authority to approve such a plan, and that approval by the full City Council would be a more appropriate and necessary course of action for such an important decision.

Councilmember Gordo stated his support for the proposed rebranding plan, however, he suggested that staff return to the City Council with recommendations on the graphics, timeline, marketing program, and any other actions required to complete the Pasadena ARTS rebranding plan so that a formal action can be taken by the full City Council.

Councilmember Madison noted that City staff should also consult with the Pasadena Convention Visitors Bureau, as well as the five Business Improvement Districts regarding the final rebranding plan, noting that their input is an important element for the proposed plan to proceed.

Councilmember Kennedy requested that staff provide him information on the approval process for such matters to be used as future reference.

By order of the Mayor and consensus of the City Council, the report was received and filed, with direction to staff to review the approval process for the Pasadena ARTS Bus Rebranding Plan and return to the City Council for formal approval with recommendations on the graphics, marketing plan, timeline, and any other required actions.

- (2) Authorize the Director of Planning and Community Development to submit the Draft Housing Element to the California Housing and Community Development Department (HCD).

Planning Commission Recommendation: On October 9, 2013, the Planning Commission recommended that the City Council forward the 2014-2021 Draft Housing Element to HCD. Additionally, the Planning Commission made a recommendation that the City Council explore creating a structure to monitor the implementation of the Housing Element.

Vincent Bertoni, Director of Planning and Community Development, introduced the agenda item. Denver Miller, Principle Planner, and Mark Hoffman, City consultant, provided an overview of the agenda report as part of a PowerPoint presentation, and responded to questions.

Councilmember Kennedy spoke on the funding challenges related to building affordable housing stock in the City, the impacts this will have on low income Pasadena residents, and suggested that a Blue Ribbon Committee comprised of affordable housing experts be appointed by the City Council to explore ways to identify possible funding sources for affordable housing in the future, and to produce a report with this information for submittal to the City Council for consideration.

David Reyes, Deputy Director of Planning and Community Development, responded to questions regarding the successful development of affordable housing in Pasadena vs. such housing stock in surrounding cities. Mr. Bertoni noted that staff will provide to the City Council a report on available affordable housing stock in the City on an annual basis.

Councilmember Tornek highlighted several of the controversial issues noted in the GPAHG letter deserving consideration in the Housing Element, such as: second units, modifying the special needs definition to include "formerly incarcerated individuals", revisions to the inclusionary housing ordinance, identification of funding sources, and health impacts to individuals residing near freeways. He stated his support for the formation of a subcommittee or a group devoted to housing issues in Pasadena to provide recommendations to the City Council, and requested that staff report back with ideas on how to provide focus on housing issues.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Tornek, to approve the staff recommendation, amended to incorporate into the Draft Housing Element the recommendations listed in the letter submitted by the Greater Pasadena Affordable Housing Group (GPAHG): H.E.- 4.6 (Homeless Housing and Services), Program Nos. 17 (Affordable Housing Preservation), 23 (Fair Housing), and 24 (Housing) Education Efforts), H.E. 4-7 (referenced on pages 14 & 25 of the Draft Housing Element), and direct staff to report back to City Council with ideas on how to provide focus on complicated housing issues, including the possible creation of a sub-committee or City commission to provide information and recommendations to the City Council on Affordable Housing Issues.
