Dear Mr. Jomsky,

I was informed that there would be a discussion about "Mansionization" at the City Council meeting scheduled for Monday, January 26. I am writing in support of protecting the character of our neighborhoods. There is a house being modified, one lot over from our home on Glen Summer Road, and I have been watching its construction with trepidation. Here are my observations.

- 1. The house being constructed is too high. The roof is above all its neighbor's chimneys. I question the permissibility of the height. Moreover, the fact that the roof is flat means that it is higher over a larger surface area, which contributes to its mansion-like appearance.
- 2. The house being constructed is too close to the street. The offset of the surrounding homes include a front patio area so that the living area is further back. Having living areas that do not match up ruins the privacy of the patio areas of houses next door. In addition, the constructed house will block the sunny south face of the house (and its patio) to its north.
- 3. We have several different styles of homes on our street, and while it is unfortunate that the new house is being constructed between and across from a cluster of extraordinarily lovely Spanish Renaissance style homes, I believe that the house being constructed could have lived agreeably among them had the city planners better accounted for the height and offset concerns that now make this a truly unwelcome house in our neighborhood.

On a possibly related note: This past year, I was approached by realtors going door-to-door, representing potential house buyers from China, and have wondered if it was just a matter of time before our Pasadena neighborhoods began to resemble those in Arcadia that are populated by mansions with only facades and square feet to recommend them. The character of our Glen Summer Road neighborhood was exactly what appealed to us when we settled here 20 years ago: It is worthy of city protection.


Takako has kindly offered to accompany us to the City Planning Department on Wednesday the 21st where we may address these concerns, plus:
