**CEREMONIAL MATTERS** 

Police Chief Phillip Sanchez introduced the new Sergeant-at-Arms, Sergeant Paul McKinney, and extended thanks to Sergeant Bobby Crees for his service as previous Sergeant-at-Arms.

Deputy Fire Chief Jon Trautwein, recognized Cody Walker, Paramedic with Reach Out Worldwide, and Pasadena Fire Fighters Dave Marguez, Matt Caffey, and Tim Okimura for their overseas volunteer relief work in Nepal due to the 7.8 magnitude earthquake that struck on April 25, 2015. The Mayor praised and thanked each of them for their service, and presented them with Certificates of Recognition for their outstanding work.

<u>Recommendation</u>: It is recommended that the City Council adopt a resolution:

- (1) Authorizing the City of Pasadena to enter into a contract with the Los Angeles Housing and Community Investment Department (LAHCID), in the amount of \$197,601 to provide Housing Opportunities for People with AIDS (HOPWA) funded rental assistance; and
- (2) Authorizing the City Manager to execute, and the City Clerk to attest, all related documents, agreements, and amendments. (Resolution No. 9429; Contract No. 22,268)

AUTHORIZATION TO ENTER INTO A CONTRACT WITH GA TECHNICAL SERVICES, INC., FOR FIBER OPTIC SPLICING, TESTING, AND EMERGENCY TROUBLESHOOTING FOR THE CITY'S FIBER OPTIC NETWORK

#### Recommendation:

- (1) Find that the proposed action is exempt from the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines Section 15061(b)(3), general rule; and
- (2) Accept the bid dated March 20, 2015, submitted by GA Technical Services, Inc., in response to the specifications to furnish labor and materials for splicing, testing, and troubleshooting of fiber optic cable, reject all other bids received, and authorize the issuance of a contract with a total not-to-exceed amount of \$155,480. The contract will have a one year term, with an option for a one-year extension, subject to the approval of the City Manager. (Contract No. 22,269)

AMENDMENT TO CONTRACT NO. 20,740 WITH THE COUNTY OF LOS ANGELES SHERIFF'S DEPARTMENT, TO INCREASE THE TOTAL NOT-TO-EXCEED AMOUNT FOR THE FINAL CONTRACT YEAR FROM \$50,000 TO \$350,000 FOR SUPPLEMENTAL LAW ENFORCEMENT SERVICES FOR MAJOR EVENTS WITHIN THE CITY OF PASADENA OTHER THAN NEW YEAR'S ACTIVITIES

#### Recommendation:

- (1) Find the proposed action is exempt from the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15061(b)(3), the general rule that CEQA only applies to projects that may have an effect on the environment; and
- (2) Authorize the City Manager to amend the existing Contract No. 20,740 with the County of Los Angeles Sheriff's Department, by increasing the contract amount for the final contract year from \$50,000 to a new total not-to-exceed amount of \$350,000, for supplemental law enforcement services for major events within the City of Pasadena other than New Year's activities. (Contract No. 20,740-1)

- (2) Accept the bid dated April 10, 2015, submitted by GRFCO, Inc., in response to Specification WD-13-01 to provide labor and materials for the installation of ductile iron water mains in Lake Avenue from Woodbury Road to Boylston Street for the Pasadena Water and Power Department (PWP), and authorize the City Manager to enter into a contract with GRFCO, Inc., for an amount not-to-exceed \$1,549,522. ## LEASE AND OPERATING AGREEMENT BETWEEN CITY OF PASADENA AND MOVE A CHILD HIGHER, INC., 4810 OAK GROVE DRIVE

#### Recommendation:

- (1) Find that a continued occupancy by Move A Child Higher, Inc. (MACH 1), and new lease for occupancy of property located at the northerly portion of Hahamongna Watershed Park from the City of Pasadena is exempt from the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines Section 15301, existing facilities, and, furthermore, that the subject lease is within the scope of the Arroyo Seco Master Plan Master Environmental Impact Report (EIR), as documented through the Hahamongna Annex Initial Study approved by the City Council on February 1, 2010;
- (2) Find that the property proposed for lease to MACH 1, located at 4810 Oak Grove Drive, Pasadena, also identified as a portion of Assessor Parcel Number 5823-003-911, was obtained for recreational use, and the proposed use is within its intended purpose; and
- (3) Authorize the City Manager to negotiate and execute a new lease and a new operating agreement between the City of Pasadena and MACH 1, a nonprofit community-based organization, incorporating the terms and conditions generally

described in the agenda report, effective May 1, 2015, and continuing through April 30, 2020.

Recommendation of Hahamongna Watershed Park Advisory Committee: At the March 24, 2015 Committee meeting, the Hahamongna Watershed Park Advisory Committee unanimously recommended that the City Council approve a lease and a new operating agreement between the City of Pasadena and MACH 1, for the operation of a therapeutic equestrian program in Hahamongna Watershed Park (HWP). (Contract No. 30177)

RECOMMENDATIONS FROM ACKNOWLEDGE THE VACANCY CREATED BY THE RESIGNATION OF COUNCILMEMBER TERRY TORNEK REPRESENTING CITY COUNCIL DISTRICT 7 AND DIRECT THE CITY CLERK TO FILE A NOTICE OF INTENTION TO FILL A VACANCY ON THE CITY COUNCIL BY APPOINTMENT IN ACCORDANCE WITH PASADENA CITY **CHARTER, SECTION 404** 

#### Recommendation:

- Acknowledge the vacancy created by the resignation of City Councilmember Terry Tornek, representing Council District 7:
- Direct the City Clerk to publish a Notice of Intention to Fill the Vacancy on the City Council by Appointment in accordance with Pasadena City Charter, Section 404; and
- (3) Provide direction to staff on the application and interview process, and approve the suggested appointment timeline for the appointment process.

Mark Jomsky, City Clerk, introduced the agenda item and reviewed the agenda report as part of a PowerPoint presentation, and responded to questions.

Councilmember Kennedy suggested that the nomination process to fill the District 7 vacancy include the City Charter provision to gather a minimum of 25 qualified signatures of registered voters living in District 7 in order to be considered by the City Council for appointment, as part of the application process, including a \$25 filing fee, noting that this will add some additional effort to the process similar to that of the elected City Council, and asked that the City Council strongly consider the matter.

Following discussion, Councilmember Gordo agreed with the added signature gathering provision, and suggested that the City Council interview each applicant publicly so that the public can observe the selection process for the Council District 7 representative.

Councilmember McAustin noted the advantages of utilizing an ad hoc committee to oversee the details of the process, and her desire for the City Council to move forward expeditiously.

Councilmember Gordo clarified that he supports an ad hoc committee being formed to develop the questions and to outline the interview process, however, reiterated the need to have all the applicants interviewed publicly for transparency purposes, including the deliberations of the City Council.

Councilmember Kennedy stated his support for the staff recommendation, with the amendment that each applicant be required to gather a minimum of 25 qualified signatures of registered voters residing in District 7 as part of the application process, including the submittal of a \$25 filing fee, formation of an ad hoc committee to develop questions and to outline the interview process for the full City Council's consideration, and to provide staff direction related to the interview process based on the proposed timeline.

In response to the City Clerk, Councilmember Gordo suggested that applicants personally obtain the 25 qualified signatures of registered voters living in District 7.

The Mayor requested that Councilmember McAustin and Masuda serve on the ad hoc committee with him to formulate the rules to the process.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Gordo, to approve the staff recommendation, including the proposed timeline, application, and selection process; amended to require each applicant, as part of the application process, to gather a minimum of 25 qualified signatures of registered voters living in District 7 for the purpose of nominating the applicant for City Council consideration and to submit a \$25 filing fee to cover signature verification costs; and to form an ad hoc committee to develop questions and any other organizational detail relating to the appointment/interview process for recommendation to the full City Council. (Motion unanimously carried) (Absent: Councilmember Madison and Vice Mayor Masuda).
