The City Clerk conducted a random alphabet drawing to determine the order of applicants to appear before the City Council during the interview process, with the results of the drawing as follows:

The Mayor reviewed the process and order of business to select an appointment to fill the District 7 vacancy, with each applicant to be given up to 6 minutes to make a presentation on his/her qualifications and interests in serving, followed by each applicant being asked the same seven interview questions by the City Council, with three minutes provided to answer each question. He noted that no applicant would be allowed in the Chamber during the interview of any other applicant, but all applicants will be allowed to return after the applicant interviews are completed to witness the deliberations and the selection of the appointee by City Council.

Each applicant gave a brief presentation on qualifications, interest in serving, and involvement in the District 7 community, and responded to the City Council's questions.

At the conclusion of all the applicant interviews, the participants were invited back to the Chamber to view deliberations and the selection process.

Councilmember Madison reiterated his previous concerns regarding the current appointment process, specifically as it relates to appointing an individual to serve/represent a district on a long-term basis (in this case, two years), stressed the need to appoint a Charter Reform Task Force to review the Charter to consider the matter relating to filling a vacancy through a special election as

oppose to an appointment process when appropriate, as well as to consider other electoral matters. He also suggested that the oath of office for the District 7 appointee be administered at the next scheduled City Council meeting and allowed to participate in the meeting at that time.

Following discussion, the City Council expressed their gratitude to the four applicants, and thanked them for their willingness to participate in the difficult selection process.

Following additional discussion, it was moved by Councilmember McAustin, to appoint Ciran Hadjian to serve the remainder of the unexpired term for the District 7 seat on the City Council from today's date until the term expires on May 1, 2017. (Motion failed due to lack of a second)
