In response, the City Manager noted that golf courses are in fact included in the water conservation effort and that pools have been considered, and are included in the City's future drought planning should there be a need for further reduction to achieve water conservation goals.

Larry Herbst, Pasadena resident, spoke regarding the increase in traffic on Avenue 64 due to the installation of several stop signs over the years, noted the impacts (increased cost, pollution, and aggravation), and asked that the City consider reducing the number of signs.

### <u>PUBLIC HEARING</u>: PROPOSED CHANGES TO THE PURCHASED WATER ADJUSTMENT CHARGE PURSUANT TO PASADENA MUNICIPAL CODE ("PMC") CHAPTER 13.20.110

**Recommendation:** It is recommended that the City Council open the public hearing and receive public comment on the proposed water rate adjustments, close the public hearing, and in the absence of a majority protest take the following action:

(1) Find that the proposed changes to the Purchased Water Adjustment Charge ("PWAC") are statutorily exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15273 (Rates, Tolls, Fares, and Charges);

(2) Approve the proposed water rate adjustments to:

- (a) Increase the PWAC by 5¢ per billing unit effective October 2015;
- (b) Increase the PWAC by an additional 2¢ per billing unit effective October 2016

The City Clerk opened the public hearing and reported that 42,133 copies of the public hearing notice were mailed on April 28, 2015; and no correspondence was received regarding the recommended action.

Shari Thomas, Assistant General Manager of Water and Power, introduced the agenda item and summarized the agenda report as part of a PowerPoint presentation.

The following individuals spoke in opposition to, and/or, expressed concerns regarding the proposed action:

Mia Hanna, Pasadena resident Craig W. Clark, Pasadena resident

Councilmember Kennedy stressed the need for the City to expand incentives/rebate programs to address the issue of water shortage/conservation, and suggested that staff present options to the City Council and community for further discussion. In response to Councilmember Kennedy, Phyllis Currie, Water and Power General Manager, stated that staff will return with additional information through the Municipal Services Committee in July 2015.

Following discussion, it was moved by Councilmember Gordo, seconded by Vice Mayor Masuda, to close the public hearing. (<u>Motion unanimously carried</u>) (Absent: None)

It was moved by Councilmember Gordo, seconded by Councilmember Kennedy, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

### <u>CONTINUED PUBLIC HEARING</u>: FISCAL YEAR 2016 RECOMMENDED OPERATING BUDGET Recommendation:

(1) Receive public comment, including regarding the Public Health and other departments listed on the June 15, 2015 Special Joint Meeting agenda; and

(2) Continue this public hearing to each subsequent regular meeting of the City Council at 7:00 p.m., until June 22, 2015 or such other date as the City Council may determine, and, at which time, the City Council will be asked to close the public hearing and formally adopt the FY 2016 Operating Budget.

The Mayor announced that now was the time for the continued public hearing.

The City Clerk reported 2 additional letters (1 letter of support of the AIDS Service Center and 1 letter from Chapcare), were received by the City Clerk's Office.

Steve Mermell, Acting Director of Public Health/Assistant City Manager, reviewed the Recommended Operating Budget for the Public Health Department as part of a PowerPoint presentation, and responded to questions.

Councilmember Gordo stressed the need to ensure that the community is aware of the proposed transition from Chapcare, and noted the importance of preserving these services, dollars, and jobs in the community.

Councilmember Kennedy expressed concerns regarding Chapcare and it not adequately serving the entire community, namely African Americans, inquired about the action plan that Chapcare has in place to address the issue, and strongly suggested that there be a discussion on what the City is doing to encourage Chapcare to better serve the community as a whole.

Margie Martinez, CHAP Chief Executive Officer, and Tom Thorman, CHAP Board Chair, addressed the issue regarding the transfer of the prenatal program, described Chapcare's proposal regarding the integration and expansion of current services provided at Chapcare to address the assignment of HIV positive patients, and responded to questions.

In response to Councilmember Kennedy's expressed concern, Mr. Thorman noted that it is important to the CHAP Board of Directors to serve all of the population, and stated his willingness to discuss the matter further with the Councilmember. Following discussion, several members of the City Council expressed concerns as it relates to terminating existing contracts with the Los Angeles County and potentially losing "Ryan White" funding, including the services associated with such funding, and stressed the need for the City to have assurances that these services will be sustained locally with the proposed transition of HIV/AIDS services to Chapcare.

Councilmember Hampton and Kennedy commented on the issue regarding Chapcare hiring Public Health Department employees that are potentially affected by the proposed transition, encouraged a stronger partnership between the City and Chapcare, with Councilmember Kennedy suggesting that Chapcare and City staff redouble efforts of providing a smooth transition as it relates to hiring affected qualified City employees.

Councilmember McAustin expressed her support for the City to transition the proposed services to Chapcare, which she noted to be a qualified/experienced provider of full-service managed medical care.

Councilmember Gordo stressed the importance of continuing to provide safety net services to the community, and strongly suggested that the City reach out to the Los Angeles County to explore ways to retain the "safety net dollars" for a sole source provider such as Chapcare.

Julie Gutierrez, Assistant City Manager, briefly discussed the General Fund 5-Year Financial Forecast, distributed material to the City Council related to each of the City departments' proposed decision packages for the City Council's review prior to the next scheduled continued public hearing, and responded to questions. Steve Mermell, Assistant City Manager, reviewed the City Manager's Office proposed decision package detail report, specifically as it relates to a Police Internal Auditor position.

Councilmember Gordo requested staff to bring forward a report with an overview on the City's plans/preparation for a potential strong El Nino event in the fall/winter.
