AN ORDINANCE OF THE CITY OF PASADENA AMENDING CHAPTER 2.120 (SENIOR COMMISSION) OF THE PASADENA MUNICIPAL CODE, INCREASING THE MEMBERSHIP OF THE SENIOR COMMISSION FROM 11 TO 13 MEMBERS

The People of the City of Pasadena ordain as follows:

SECTION 1. Pasadena Municipal Code, Title 2, Chapter 2.120, Section

2.120.030 (Senior Commission) is amended to read as follows:

"A. The commission shall consist of 11 13 members, who shall be appointed as

follows:

1. Each of the 7 councilmembers and the mayor shall nominate 1 member

for a total of 8 members.

2. The mayor shall nominate 1 member from persons recommended by the 7 councilmembers.

3. The Pasadena Senior Center shall nominate 1 member from its active

employees.

4. The Huntington Hospital Senior Care Network shall nominate 1

member from its active employees.

3 <u>5.</u> Human services agencies providing services in Pasadena shall recommend <u>nominate</u> 2 members to the senior commission for nomination to the city council; provided, that, <u>and</u> each nominee must represent an agency primarily providing

services to Pasadena senior residents. The nomination process shall be set forth in the commission's rules and regulations.

4 6. All appointments <u>nominations</u> are subject to ratification by the city council.

B. Members shall be appointed for a term of three years, and shall serve no more than two consecutive terms. A term of less than one year shall not be considered a full term. Members shall serve staggered terms which expire on June 30th of the applicable years. A member shall continue in office for the term for which he/she was appointed or until his/her successor is appointed. No member who has served two consecutive terms shall be eligible for reappointment to the commission prior to the passage of a two-year interval.

C. If a member <u>nominated by the mayor or councilmembers</u> ceases to reside in the city prior to the expiration of a term, the member may complete the term only upon approval by the city council pursuant to Section 2.45.020. <u>Members</u> <u>appointed pursuant to subdivisions (A)(3), (4), and (5) are not required to be</u> <u>Pasadena residents.</u>

D. Any member of the commission may be removed by the city council at its pleasure."

SECTION 2. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.
