<u>Recommendation</u>: It is recommended that the City Council conduct a public hearing to consider the following actions:

(1) Adopt a resolution certifying the Final Environmental Impact Report (FEIR) and adopt a Mitigation Monitoring and Reporting Program for a music and arts festival to occur in the Rose Bowl and on Brookside Golf Course;

(2) Adopt a resolution adopting a Statement of Overriding Considerations for a music and arts festival to occur in the Rose Bowl and on Brookside Golf Course;

(3) Authorize the General Manager of the Rose Bowl Operating Company (RBOC) to finalize negotiations and enter into a License Agreement of up to 20 years between the RBOC/City of Pasadena and Anschutz Entertainment Group (AEG) for the Arroyo Seco Music and Arts Festival;

(4) Direct the City Clerk to file a Notice of Determination with the Los Angeles County Recorder within 5 days; and

(5) Conduct first reading of an ordinance amending the Pasadena Municipal Code Section 3.32 (Arroyo Seco Public Lands Ordinance) to increase the number of displacement events from 12 to 15 per year without requiring further approval of the City Council and to allow amplified sound and increased uses on the Brookside Golf Course to accommodate the Arroyo Seco Music and Arts Festival (See Item No. 10 below). (Resolution No.'s 9492 and 9493)

Recommendation of the Rose Bowl Operating Company: As required by the Operating Agreement between the City and the Rose Bowl Operating Company ("RBOC"), on March 24, 2016, the RBOC Board of Directors reviewed the proposed amendment to Title 3, the license agreement overview and the FEIR, and formally recommended approval of each by the City Council. Members of the public asked questions at the time, and while oral responses were given, further elaboration is provided in Attachment D of the agenda report.

The City Clerk opened the public hearing and reported that the notice of public hearing was published on March 17, 2016 in the <u>Pasadena Journal</u>. The City Clerk's office received 36 letters of correspondence, with 25 letters expressing support, 9 letters expressing opposition, and 2 letters providing general comments regarding the recommended action.

Darryl Dunn, General Manager of the Rose Bowl, David Sanchez, Senior Planner, George Cunningham, Rose Bowl Chief Operating Officer, Addie Ferrell, Environmental Science Associates (consultant), John Muggridge, Fehr & Peers (consultant), Martha Saucedo, AEG, Nic Adler, AEG, and Dave Revel, Tech Md Inc. (consultant), participated jointly in a PowerPoint presentation on the agenda item, and responded to questions.

Fire Chief Bertral Washington and Pasadena Police Lieutenant Art Chute provided information on public safety issues related to the Arroyo Seco Music and Arts Festival (Festival).

Councilmember Gordo, President of the Rose Bowl Operating Company Board (RBOC), provided an overview of the RBOC's review of the project, and provided information on the various events held at the Rose Bowl in the last five years.

Councilmember Hampton expressed concerns with continued references to the National Football League (NFL) in the Pasadena Municipal Code (PMC), Section 3.32.275, Temporary Increase In Displacement Events, and requested that this be removed from the PMC. In addition, Mr. Hampton urged the City Council to include a provision in the proposed ordinance that would set a limit to the total number of displacement events at the Rose Bowl to 15 allowable events.

Following Councilmember Hampton's concerns regarding private properties and Pasadena Unified School District sites being utilized as parking lots for Rose Bowl events, David Reyes, Interim Director of Planning and Development, replied that the City's Code Compliance division will be notified to surveil and prevent public parking on private lots in association with the Festival.

Following discussion, Councilmember Wilson expressed concerns with the lack of incentives for ticket holders attending the Festival to utilize public transportation and/or walk, and urged staff and the promoter to fully explore such options.

Councilmember Madison stated the importance of enforcing and managing the surrounding Rose Bowl neighborhood perimeters and his preference that necessary unfunded maintenance projects within the Arroyo Seco and/or Rose Bowl be funded from revenues generated by the Festival.

Councilmember McAustin requested that staff, per the mitigation and monitoring section in the agenda report, provide annual reports on the impacts and successes of the Traffic Management Plan for each year's Festival.

Councilmember Kennedy requested that staff contact Mr. Robert Miller, Bus and Coach of America, a local transportation company that provides electrical buses, regarding potential transportation/shuttling contracting opportunities needed for displacement events in the Arroyo Seco and at the Rose Bowl. The Mayor expressed concerns with the Festival's operating hours and requested that the Festival programs/performances end prior to 11:00 p.m. on Sunday nights. He also voiced his support for limiting the number of displacement events held at the Rose Bowl to 15 per calendar year, and suggested that as staff develops and adjusts plans for future. Festivals, consideration be given to placing intercept or satellite parking sites in locations such as the San Fernando Valley and West Los Angeles (similar to the parking program for the Hollywood Bowl), providing incentives for attendees to utilize alternate transportation options other than driving into the Arroyo Seco.

Following discussion, Councilmembers Gordo, Kennedy, Wilson, and McAustin expressed concerns in setting a maximum number of 15 displacement events at the Rose Bowl without sufficient information regarding the success of the Festival, understanding what other events/opportunities might emerge in the future, and needing sufficient time to consider and discuss the matter more thoroughly.

Councilmember Wilson requested that staff provide an informational report each year following the event to the City Council on the Festival operations, including traffic and neighborhood impacts, during the initial three-year portion of the contract.

Councilmember McAustin requested that the RBOC Board agendize a discussion regarding suggested improvements related to oversight of programming in the Arroyo Seco and at the Rose Bowl, with particular attention to management of smaller events, and report back to the City Council on any recommendations that might be considered.

Following discussion, it was moved by Vice Mayor Masuda, seconded by Councilmember Gordo, to close the public hearing. (Motion unanimously carried) (Absent: None)

In response to Councilmember Wilson's inquiry of who will be responsible for incorporating the recommendations and suggestions that were made during the discussion of the agenda item, Darryl Dunn, Rose Bowl General Manager, responded that City and RBOC staff will follow up as appropriate.

Following discussion, it was moved by Councilmember McAustin, seconded by Councilmember Wilson, to amend staff recommendation No. 3 as follows: Authorize the General Manager of the Rose Bowl Operating Company (RBOC) to finalize negotiations and return to the City Council with a draft of the License Agreement of up to 20 years between the RBOC/City of Pasadena and Anschutz Entertainment Group (AEG) for the Arroyo Seco Music and Arts Festival (Following discussion the motion was withdrawn)

Following further discussion, it was moved by Councilmember Gordo, seconded by Councilmember McAustin, to approve the staff recommendation (Nos. 1, 2, 3, and 4, as detailed above). (Motion unanimously carried) (Absent: None)
